| <p> This procedure can now be accessed on the FIAweb.</p> <p>Requesting access to the EBT web site</p> <p>Contacting the EBT Help Desk</p> | <p>The purpose of this policy bulletin is to notify Job Center and Non Cash Assistance Food Stamp (NCA FS) Center staff that they are not permitted to access the Electronic Benefit Transfer (EBT) cardholder web site (www.ebtaccount.jpmorgan.com) to obtain applicant/participant EBT account information. Access to an EBT account requires the applicant's/participant's Personal Identification Number (PIN)/Password and under no circumstance should staff solicit this information from an applicant/participant.</p> <p>The limit of staff involvement with the EBT web site is only to provide the web address, www.ebtaccount.jpmorgan.com, to applicants/participants who request it. Applicants/participants who require additional information or need help with EBT-related issues may call the number listed on the back of their EBT card, 888-328-6399, for assistance.</p> <p>Staff having a need for EBT account information may request it from the Job or NCA FS Center administrative staff that is authorized to use the EBT Administrative Terminal. Authorized administrative staff whose password is no longer active must obtain a new password by submitting the Administrative Terminal Password Request Electronic Benefits Transfer (EBT) Services (EBT-56) form.</p> <p>Additional information and/or assistance with EBT-related questions may be obtained from the EBT Help Desk by calling the EBT Services Hotline at 212-331-4233. (Please note that this number is for Agency staff only and is not to be provided to applicants/participants.)</p> <p><i>Effective Immediately</i></p> |
