| Note: Beginning August 29, 2012 any reference to the Food Stamp Program shall mean the Supplemental Nutrition Assistance Program (SNAP) and any reference to Food Stamps (FS) shall mean SNAP benefits. | Met Council has been added as a participating Community-Based Organization (CBO) in Brooklyn, Bronx, and Manhattan. The Food Bank for New York City has been added as a participating CBO in Brooklyn and the Bronx. Child Development Support Corporation has been added as a CBO site in Brooklyn Part of the Solution has been added as a CBO site in the Bronx Yorkville Common Pantry and Cathedral Community Cares have been added as CBO sites in Manhattan, both under the umbrella of the New York City Coalition Against Hunger. The phone number for WHEDCO has been changed. The list of zip codes has been revised. A footnote, denoted by a double asterisk, has been added to advise participants that beginning August 29, 2012, any reference to Food Stamps shall mean Supplemental Nutrition Assistance Program (SNAP) benefits. The bilingual (English and Spanish) flyer advises the Food Stamp households that they may be able to recertify their Food Stamp case at a CBO in their neighborhood. Management Information Systems (MIS) will mail FLY-86 to NCA FS households who are scheduled for recertification and who reside in any of the zip codes listed on FLY-86. | | | | | | |
