## FAIR HEARING CONFERENCE REFERRAL FOR ELIGIBILITY REVIEW PROCESS

Date: September 13, 2012	Subtopic(s): Fair Hearing
This procedure can now be accessed on the FIAweb.	The purpose of this policy bulletin is to inform Job Center and Fair Hearing and Conference (FH&C) staff of the new system generated <b>105F</b> (FTR/FTC to Eligibility Appt) New York City Work, Accountability and You (NYCWAY) Action Code.
	This policy bulletin also serves to remind Job Center staff that they <b>must</b> enter Action Code <b>11FK</b> (Referral from FH&C for Eligibility Assessment Kept) when participants meet with them after being referred by FH&C. FH&C will refer participants using Action Code <b>11FH</b> and the Fair Hearing and Conference (FH&C) Unit Referral for Eligibility Review ( <b>W-180R</b> ) form.
	Additionally, the <b>W-180R</b> form has been updated to clarify the referral language and to provide a space to capture the participant's signature.
	When a participant's adverse eligibility related action is resolved in a conference with FH&C, the FH&C staff will:
FH&C Worker	<ul> <li>Review NYCWAY to find the infraction and post an 820/series Action Code to settle it (if the eligibility infraction occurred in NYCWAY).</li> <li>Post Action Code 11FH (Referral from FH&amp;C for Eligibility</li> </ul>
	<ul> <li>Assessment) in NYCWAY.</li> <li>Select the original eligibility infraction from the Drop-down menu attached to the <b>11FH</b> in NYCWAY.</li> </ul>
	<ul> <li>Write a detailed case note entry using the comment section of the 11FH in NYCWAY.</li> </ul>
	• Annotate the <b>W-180R</b> with the outstanding eligibility issue(s), sign and date the form and provide his/her telephone number.
