| <p> This procedure can now be accessed on the FIAweb.</p> | <p>The purpose of this policy bulletin is to inform all Job Center and Non Cash Assistance Supplemental Nutrition Assistance Program (NCA SNAP) Center staff that eight (8) forms for the recurring semiannual schedules have been revised to reflect the dates from January 2013 through June 2013.</p> <p>Additionally, Forms W-140XX and W-205RR have been reformatted.</p> <p>The semiannual 2013 schedules are:</p> <ul style="list-style-type: none"> • EBT Pick-up Schedule January – June 2013 (EBT-52A). This form informs applicants of the date when their benefits are first available to them. • Eligibility Resolution Due Dates for Processing Discrepant Information by Lead Type (W-140XX). This form advises staff on the various due dates for processing changes reported by households as well as information received from computer matches and other automated lists. • Recurring Roll Deadline Schedule January – June 2013 (W-203A). This form advises staff of the recurring case processing schedule and provides staff with the dates by which changes in a case must be submitted. • Check Replacement Schedule January – June 2013 (W-203BB). This form advises staff of the date by which an action must be taken to ensure that the proper benefit cycle is generated. |

- NCA Toe Digit Deadline Schedule January – June 2013 (**W-203EE**). This form advises staff of the recurring case processing schedule and provides staff with the date by which any action changes regarding SNAP cases must be submitted.
- Family Assistance and NCA SNAP Application Timeliness Schedule January – June 2013 (**W-204TT**). This form advises staff of the recurring case processing schedule that provides the eligibility decision due dates for Family Assistance and NCA SNAP applications.
- Safety Net Assistance Application Timeliness Schedule January – June 2013 (**W-205RR**). This form advises staff of the recurring case processing schedule that provides staff with the eligibility decision due dates and benefit availability dates for Safety Net Assistance (SNA) applications.
- Cash Assistance, Medical Assistance and Supplemental Nutrition Assistance Program (SNAP) Certification Desk Guide (**W-205W**). This form instructs staff on how to manually enter certification periods on Forms **LDSS-4013A NYC**, **LDSS-4013B NYC**, **LDSS-4014A NYC**, and **LDSS-4014B NYC**.
