## INTRODUCTION OF THE CONTINUATION OF CHILD CARE BENEFITS NOTICE (FIA-1094r)

<b>Date:</b> January 31, 2014		Subtopic(s): Child Care, Notices	
☐ This procedure can now be accessed on the FIAweb.	The purpose of this policy bulletin is to introduce Job Center staff to a new notice Continuation of Child Care Benefits ( <b>FIA-1094r</b> ).		
	The <b>FIA-1094r</b> is a system generated notice that will be sent to parents/guardians that received an erroneous Notice of Intent to Discontinue Child Care Benefits ( <b>W-273YY</b> ). The notice informs the parent/guardian that the <b>W-273YY</b> was sent in error and that the child care will not be terminated. It also informs the parent/guardian that he/she does not need to take any action and a notice will be sent when the re-enrollment of his/her child with his/her child care provider is completed. The notice includes a phone number that the parent/guardian can call if he/she has any questions.  Effective Immediately
