The following **<u>changes</u>** have been made to this Case Header:

- Activity Status field has been moved from the top right hand corner to the bottom right hand corner
- **Responsible Center** label is now displayed as "**RESP CTR**" and it has been moved from the top left hand corner to the top right hand corner
- Originating Center label is now displayed as "ORIG ID" on the the top center position
- Home Center "HOME CTR" field has been added and is displayed at the top left hand corner

• PAM will generate the "**ORIG ID**" once the Data Entry Supervisor assigns the PAM Activity to the Data Entry Operator. Data Entry Operator's enrollment Center' will be populated in the **ORIG ID** field, if the activity fails data entry [i.e.'Failed Data Entry' Status], **ORIG ID** will be cleared [reset].

- The Batch Type field can be modified when the PAM activity status is in "*Draft*", and/or "*Returned by Supervisor*" and/or "*Returned by Data Entry*".
- The existing Batch Number logic for all other activity types remains the same.
