	<ul> <li>Recurring Roll Deadline Schedule January – June 2015 (W-203A). This desk guide advises staff of the dates by which changes on the CA case must be processed in the Welfare Management System (WMS) to meet the next recurring cycle based on the case number toe digit.</li> </ul>
	NCA Toe Digit Deadline Schedule January – June 2015 (W-203EE). This desk guide advises staff of the date by which any changes on a SNAP case must be processed in WMS to meet the next recurring cycle based on the case number toe digit.
