The following codes have been added to the desk guide:

Code	Description
G81	Non-Cooperative Caretaker (only child/all children without valid Social Security number [SSN] or application for SSN)
M40	Intentionally Providing Incorrect Information (applicant intentionally supplies Agency with incorrect information during application process)
M81	Failure to Provide Verification (identity: driver's license, non-driver's photo ID, military ID, birth certificate, baptismal papers or adoption papers)
M82	Failure to Provide Verification (school attendance records)
N70	Failure to Provide Verification (assets or resources: deed, savings statement or bank book)
N71	Failure to Provide Verification (citizenship: naturalization papers or passport)
N72	Failure to Provide Verification (one-person cases or households with all case members lacking valid SSNs or applications for SSNs)

*If SNCA/SNNC case, a Separate Food Stamp Determination is required. If FA/SNFP, case may be eligible for five months of Transitional Food Stamp benefits.

When rejecting a PA/FS application, FS Reject Code **J05** must be entered in element **331** (FS Reason) of the TAD. This is the only RJ Code that will create Sep Det FS case when PA/FS are being denied at the same time.
