

### **NYCWAY UPDATES - EP AND ACTION CODE CHANGES**

NYCWAY is updated on a regular basis to make the system more helpful to users and to update current policy. The purpose of this policy bulletin is to inform staff of the following updates made to NYCWAY:					
<ul> <li>Other Personal Issues – Participant Exemption Changes</li> </ul>					
<ul> <li>New Wellness, Comprehensive Assessment, Rehabilitation and Employment (WeCARE) Vendor Action Codes</li> </ul>					
<ul> <li>New Training Assessment Group (TAG) Child Care Codes 133E (TAG CC Return Appointment – Documentation) and 133F (TAG CC Return Appointment – Provider)</li> </ul>					
Previously all exemptions for participants were posted outside the Employability Plan (EP). Workers can now post the exemptions from within the EP:					
When a Y is entered for Other Personal Issues? on the Primary Questionnaire screen for participants, the Other Categories screen listing the exemption categories appears.

Action Code **196** exempts the PA individual if the child under 13 weeks is on the case for FS only.

### New TAG Child Care Codes 133E and 133F

Effective December 15, 2006, TAG Child Care Return Appointment Action Codes **133E** and **133F** will be offered to post through the EP by TAG workers only, instead of the **133D** (Child Care Return Appt – Documentation Needed) and the **133S** (Child Care Return Appointment – Provider Needed).
