### NYCWAY UPDATES – ACTION CODE CHANGES

<b>Date:</b> August 24, 2007	<b>Subtopic(s):</b> NYCWAY
This procedure can now be accessed on the FIAweb.	<p>NYCWAY is updated on a regular basis to make the system more helpful to users and to update current policy. The purpose of this policy bulletin is to inform staff of the following updates made to NYCWAY:</p>
<p>Change in ACCIS Child Care Codes</p>	<ul style="list-style-type: none"> <li>• New Automated Child Care Information System (ACCIS) Child Care Codes</li> <li>• New Travel Accommodation Action Code <b>16TQ</b> (WC Travel Accommodation: Appointment Queue)</li> </ul>
<p>Combo means multiple child family with different child care types</p>	<p>Effective immediately, the Child Care Action Code <b>133P</b> (Paid Child Care in ACCIS) has been replaced by the following system-generated codes:</p> <ul style="list-style-type: none"> <li><b>13AC</b> (Paid Combo Child Care in ACCIS)</li> <li><b>13AF</b> (Paid Formal Child Care in ACCIS)</li> <li><b>13AI</b> (Paid Informal Child Care in ACCIS)</li> </ul>
<p>New Travel Accommodation Action Code <b>16TQ</b></p>	<p>The Action Code <b>133Y</b> (ACCIS Child Care Is Terminated) remains unchanged.</p> <p>Effective September 10, 2007, a new Action Code <b>16TQ</b>, which is entered by Wellness, Comprehensive Assessment, Rehabilitation and Employment (WeCARE) vendors only, will identify individuals who are medically incapacitated and require special accommodations. When these individuals appear for a Face to Face Recertification (FFR) appointment at the Bushwick (66), Hamilton (28) or Concourse (45) Model Center, the PA Recertification ticket will appear in red in Model Office Numbering, Identification, and Queuing (MONIQUE) and the system will prevent the assigned JOS/Worker from selecting any ticket other than that red ticket until a participant with the <b>16TQ</b> has completed his/her appointment.</p>
