REVISIONS TO FORM M-42U AND FORM W-138Q

<p> This procedure can now be accessed on the FIAweb.</p>	<p>The purpose of this policy bulletin is to inform staff at Job Centers and Non-Public Assistance (NPA) Food Stamp (FS) Offices that the Non-Public Assistance Food Stamp Offices and Associated Medicaid Offices form (M-42u) and the Food Stamp Income Guidelines form (W-138Q) have been revised to reflect changes in the hours of operation at the Union Square NPA Food Stamp Office (F-11) and the Waverly NPA Food Stamp Office (F-19).</p> <p>The new hours of operation are as follows:</p> <ul style="list-style-type: none"> • Union Square NPA Food Stamp Office, 109 East 16th Street, New York, N.Y. 10003, will be open Monday-Friday from 8:30 AM to 5:00 PM. It will no longer be open on Saturdays or have extended hours. • Waverly NPA Food Stamp Office, 12 West 14th Street, New York, N.Y.10011, will be open Mondays, Wednesdays, Thursdays and Fridays from 8:30 AM to 6:00 PM; Tuesdays from 8:30 AM to 7:00 PM; Saturdays from 9:00 AM to 5:00 PM. It will now have extended hours of operation. <p>Additional changes:</p> <p>M-42u</p> <ul style="list-style-type: none"> • In the Food Stamp Offices column, and the Associated Medicaid Offices column, the text “extended hours” has been removed from the F-11* Union Square designation. <p>W-138Q</p> <ul style="list-style-type: none"> • The text “Union Square – F-11* 109 East 16th Street, 6th floor New York, N.Y. 10003” has been removed from the Extended Hours Centers column and replaced with “Waverly – F-19 12 West 14th Street, 6th floor, New York, NY 10011.”

Food Stamp Income Guidelines

- Food stamps provide your family with assistance when buying food. They are used in place of cash to buy food at grocery stores or supermarkets.
- You don't have to be out of work to apply for food stamps. You can be employed and still be eligible for food stamps.
- You can own your own home and car and still be eligible for food stamps.
- If you are eligible, you will receive Food Stamp assistance within 30 days. Certain households with little income or savings, or with high shelter costs, can receive Food Stamp benefits within five days.

Food Stamp Resource Limits/Exemptions

The Food Stamp resource limits (including bank accounts, savings bonds and cash on hand) are as follows:

- \$3,000 for a household where at least one person is elderly (60 years or older) or disabled
- \$2,000 for all other households

Please note: Other resource items and/or exceptions may apply. We will notify you of any other items and exemptions when you apply for benefits.

Límites/Exenciones de Recursos respecto a Cupones para Alimentos

- \$3,000 para los hogares con por lo menos una persona anciana (60 años o más de edad) o incapacitada
- \$2,000 para todos los demás hogares
