### **EXTENSION OF THE WORK ADVANTAGE PROGRAM CONVERSION DATE**

The purpose of this policy bulletin is to inform all Job Center staff that the Opportunity to Participate in Work Advantage ( <b>EXP-84A</b> ) notice has been revised because the time limit for Housing Stability Plus (HSP) cases to convert to the Work Advantage program has been extended to April 24, 2009.
See PD #08-32-ELI	Participants who are employed at least 20 hours per week and are participating in the HSP program, are being sent form <b>EXP-84A</b> , even if their case is closed and they are no longer in receipt of Cash Assistance (CA). The form informs participants that the opportunity to convert to the Work Advantage program is available through April 24, 2009. Participants can also call (212) 331-4200 for additional information about the Work Advantage program.
	Note: Participants whose HSP case was in the Advent Unit at Hamilton Model Center #28 (now being serviced at the East End Model Center #23), Crotona Center #46, or Linden Model Center #67, should call (212) 331-4430 to find out what Center to go to to apply for Single Issuance (SI) status.

Congratulations on your employment that has enabled you to leave Cash Assistance (CA). While on Housing Stability Plus (HSP), you were sent a letter telling you about the opportunity to convert to the Work Advantage program, the City's new rental assistance program. If you are still employed at least 20 hours weekly, this opportunity is available through April 24, 2009, and is available to you even though your CA case has closed. If you have questions about the Work Advantage program, call **212-331-4200**, Monday through Friday between the hours of 9:30 AM and 4:30 PM.

If you would like to participate in the Work Advantage program you need to apply for and receive a special Single Issuar ce (SI) status in order to receive a Work Advantage certification letter in the mail from the Department of Homeless Services (DHS). To apply, please go to Job Center #18 (the Riverview Annex at 132 West 125th Street, 2nd Floor, New York, NY 10027). Please bring this letter along with recent pay stubs.
