### SUBJECT: The Child Support Pay It Off Program

The purpose of this Center Director (CD) memorandum is to inform Benefits Access Center (BAC), Non-Cash Assistance (NCA) Supplemental Nutrition Assistance Program (SNAP), and HIV/AIDS Services Administration (HASA) staff of the Pay It Off Program that is being offered from June 1, 2023 through June 30, 2023 by the Office of Child Support Services (OCSS). It is informational for all other staff.

The Pay It Off Program provides Non-Custodial Parents (NCP) who have child support debt permanently owed to the New York City (NYC) Department of Social Services (DSS) an opportunity to have their payment matched by the Human Resources Administration (HRA); therefore, significantly reducing their debt. Over the years, approximately \$17 million in child support debt has been reduced through this program.

In order to take advantage of this opportunity, NCPs must pay their court-ordered current child support amount for June 2023 and a minimum of \$500 toward their NYC DSS child support debt, and HRA will reduce their debt by double, up to the amount that is owed. NCPs who pay their DSS money judgement principal in full will have their DSS interest waived.

To help encourage consistent child support payments, which are relied on by lowincome families, NCPs may also be eligible for an additional \$2,500 debt reduction to arrears owed to NYC DSS when applying for the Arrears Credit Program (ACP) during the month of June 2023. The ACP can be used to reduce up to \$15,000 of child support debt owed to NYC DSS over a three-year period. The NCP must inquire about this program. They can also inquire about other debt reduction programs that are offered by OCSS throughout the year. Helping NCPs reduce debt is important to individuals and families. Debt from any source can have a negative impact on an individual's mental and physical health. Studies have shown that high amounts of child support debt can discourage connection to formal employment among NCPs. Reducing child support debt may also lower NCP child support payments. Additionally, child support debt has been connected to higher levels of parental discord and lower levels of father involvement, which can impact the well-being of a child.

Step 4 Lower your debt even more Sign up for the Arrears Credit Program (ACP) Receive a one-time \$2,500 debt reduction to arrears owed to NYC DSS when applying for ACP in June 2023. Pay your monthly court ordered obligation in full for a year and get \$5,000 off your NYC DSS debt at the end of 12 months. Stay in the program for up to three years, and get a total of \$15,000 taken off your NYC DSS debt. See details at nyc.gov/ocss-debtreduction. Money Judgment Interest If you pay off the principal on your money judgment payable to NYC DSS, your interest will be eliminated.
