OBSOLETION OF POLICY DIRECTIVE #01-70-ELI AND NEW WAY TO RECERTIFY YOUR CONTINUED ELIGIBILITY FOR MEDICAID (W-126F)

<p>☞ This procedure can now be accessed on the FIAweb.</p> <p>☞ Forms can now be accessed through Print on Demand at all Job Centers.</p>	<p>The purpose of this policy bulletin is to inform staff that the New Way to Recertify Your Continued Eligibility For Medicaid form (W-126F) (Rev. 11/5/01) is now obsolete.</p> <p>The W-126F should no longer be included in the Food Stamp application kit (“A” kit).</p> <p>In addition, staff should no longer refer to Policy Directive #01-70-ELI (Food Stamp and Medicaid Dual Recertification), as the information contained in the directive is now obsolete.</p> <p>Location heads must ensure that all versions of the W-126F and PD #01-70-ELI are recycled.</p> <p><i>Effective Immediately</i></p> <p>Attachment:</p> <p>W-126F New Way to Recertify Your Continued Eligibility for Medicaid (Rev. 11/5/01) (Obsolete)</p>

New Way to Recertify Your Continued Eligibility For Medicaid

The Human Resources Administration is happy to announce that you can now recertify your continued eligibility for Medicaid at this food stamp recertification interview. You may no longer have to keep a face to face recertification appointment at the Medical Assistance Program as long as you remain eligible for food stamp benefits. Your food stamp Worker will explain exactly who on your food stamp case can be recertified for Medicaid and will ask you to give written permission allowing us to make a Medicaid predetermination. If you have any questions, your food stamp Worker will answer them today.

Nueva Manera de Recertificar Su Elegibilidad Continua Para Medicaid

La Administración de Recursos Humanos se complace en anunciar que usted ahora puede recertificar su elegibilidad continua para Medicaid en ésta entrevista de recertificación de cupones para alimentos. Puede que usted ya no tenga que acudir a una cita de cara a cara en el Programa de Asistencia Médica (Medical Assistance Program), siempre y cuando usted permanezca siendo elegible para beneficios de cupones para alimentos. Su Trabajador de cupones para alimentos le explicará exactamente quién en su caso de cupones para alimentos puede ser recertificado para Medicaid y le pedirá que nos de permiso por escrito para permitirnos hacer una predeterminación de Medicaid. Si tiene cualquier pregunta, su Trabajador de cupones para alimentos se las contestará hoy.
