NYCWAY UPDATES – NEW AND DISABLED ACTION CODES

Date: August 13, 2004	Subtopic(s): NYCWAY
This procedure can now be accessed on the FIAweb.	NYCWAY is updated on a regular basis to make the system more helpful to users, and to update current policy. This policy bulletin is to inform staff of the following updates and enhancements made to NYCWAY:
Disabling of Action Codes 194 and 194C	Action Codes 194 (Referral for Case Control to SSI – Pending) and 194C (Referral To SSICC: CSA CASE) are SSI pending action codes which would temporarily exempt an individual from the work requirements. These codes have been disabled due to a change in policy. HS Systems (HSS) is the only entity that can exempt an applicant/participant because s/he is pending an SSI determination.
Disabling of Action Code 183A	The Action Code 183A (Grandparent Prov Care Child Teen Parent In School) was used to exempt grandparents from work activities when they were needed at home to provide care for grandchild(ren). This code is now being disabled because HRA pays child care so that a work-rules required grandparent can be engaged.
New Action Code 170A	<p>Action Code 170A (Fair Hearing Outcome Confirmed) was developed to serve as confirmation that a Fair Hearing outcome has been issued by the State. The code will close out Action Codes 710 (Fair Hearing Requested-Aid To Continue), 711 (Fair Hearing Requested/Contesting Employability) and 715 (Fair Hearing Requested-Non Aid To Continue).</p> <p>The JOS Worker enters the 170A when a participant brings in documentation to the Job Center confirming that a Fair Hearing decision was issued by the State.</p>
