<p> This procedure can now be accessed on the FIAweb.</p> <p> Forms can now be accessed through Print on Demand at all Job Centers.</p>	<p>As detailed in previous policy bulletins issued since July 2001, HRA is in the process of translating selected applicant/participant forms into multiple languages.</p> <p>The attached forms have been translated and are available on the FIAweb in Arabic, Chinese, Haitian Creole, French, Korean, Russian, Vietnamese, and Yiddish. Center Directors must ensure the forms are available and that they are used appropriately.</p> <p>Workers must provide both the foreign language and the English version of a form to applicants/participants whose primary reading language is one of the languages translated.</p> <p>For assistance accessing the FIAweb, contact your Center’s Computer Liaison.</p> <p>For Print on Demand training, call (718) 246-3693.
