# TREATMENT OF HURRICANE EVACUEES APPLYING FOR CASH ASSISTANCE (CA) AND SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) BENEFITS

	Evacuees		
	The purpose of this policy bulletin is to provide guidance to Job Center, Non-Cash Assistance Supplemental Nutrition Assistance Program (NCA SNAP) Center and HIV/AIDS Services Administration		
	(HASA) staff on how to process applications to meet the needs of individuals and families who state they are evacuees of Hurricane Harvey, Irma or Maria.		
	Each individual or family displaced as a result of Hurricane Harvey, Irma or Maria will present with different needs, possibly including the need for special accommodations, and must be handled accordingly.		
	Cash Assistance Applications		
	There are certain requirements that staff must adhere to in processing Cash Assistance (CA) applications of evacuees of Hurricane Harvey, Irma or Maria.		
	<ul> <li>Each applicant for emergency assistance or recurring CA must complete a New York State Application for Certain Benefits and Services(LDSS-2921) and have a face-to-face interview.</li> </ul>		
	<ul> <li>Many evacuees will not have documentation with them and may not be able to secure documentation for some time.</li> <li>Self-declarations and collateral sources (e.g. attestations from family and friends) may be the only verification available and must be used to satisfy document requirements such as:         <ul> <li>identity;</li> </ul> </li> </ul>		
	income;		
	resources;		
	citizenship status; and		
	■ relationship.

- The authorization of recurring benefits must not be delayed pending verification/documentation of required items.
- The Social Security Validation process may assist staff with establishing identity.
- Verification from other states as to whether or not a family has received 60 months of Temporary Assistance to Needy Families (TANF) funded benefits may also not be available for some time. The JOS should ask the individual/family how long they have received TANF funded benefits and use this information to determine the CA category of assistance until documentation becomes available.
- Displaced evacuees may be eligible for emergency assistance, including the need to help establish a home. For persons with income who do not qualify for recurring Safety Net Assistance (SNA), immediate needs may be met under Emergency Safety Net Assistance (ESNA) category since the emergency is related to a catastrophe and the 125% gross income test does not apply.
- The JOS must not attempt to consider, as income or resources, any CA benefits received in the home state or territory of displaced evacuees prior to their resettlement in New York.
- Income that is received, such as Social Security Benefits, must be budgeted using normal budgeting procedures. Initially displaced evacuees may not have such income but may begin to receive it at a later date. Applicants who were receiving or who may be eligible for such benefits should be directed to the local Social Security Administration for help reinstating this source of income.
- The JOS must determine if an applying hurricane evacuee individual or family is eligible to receive any additional allowances based on their actual circumstances. For example, if the individual or family is housed where they are not able to prepare meals or where meals are not provided in the residence, the JOS must determine if a restaurant allowance is appropriate.

### SNAP Applications

#### **Evacuees from Gulf Coast States**

The special processing rules for SNAP applications of evacuees from Gulf Coast States affected by Hurricanes Harvey and Irma expired on September 30, 2017. Regular SNAP processing rules now apply to those evacuees (e.g. Texas and Florida) who apply in New York on or after October 1, 2017.

#### **Evacuees from Puerto Rico**

The United States territory of Puerto Rico does <u>not</u> participate in SNAP and has its own federal food assistance program known as the Nutrition Assistance Program (NAP). NAP is not interoperable with SNAP and NAP benefits cannot be used outside of Puerto Rico.

The United States Department of Agriculture (USDA) issued instructions to advise states to serve evacuees from Puerto Rico, including those receiving NAP, through regular SNAP eligibility rules.

Puerto Rican evacuee families may be treated as separate households from the family with whom they reside. JOS/Workers are reminded that while regular SNAP eligibility and application processing rules apply to Hurricane Maria evacuees, evacuee households residing with another household may be treated as separate SNAP households even if the households are currently purchasing and preparing food together.

As a result of the hurricanes, Puerto Rico does not have the capability to close or process changes to NAP cases. Therefore, hurricane evacuees **identified as NAP households** must attest, either orally or in writing that the applicant understands that no member may receive both NAP and SNAP benefits at the same time, and that the household will request its NAP case to be closed at the earliest possible opportunity.

The USDA has provided samples of an affidavit which should be used by evacuees identified as NAP households. The signed affidavit should be scanned and indexed in the **Document description** field under "Affidavit for SNAP applicants receiving NAP displaced from Puerto Rico". If the household prefers not to submit a written attestation, they should be read the affidavit and asked to attest to it orally. The JOS/Worker is required to document household's response in the case notes.

Self-declaration and collateral resources.

Many evacuees will not have documentation with them and may not be able to secure documentation for an extended period of time. Self-declarations and collateral sources (e.g. attestations of family or friends) may be used to satisfy document requirements. Providing recurring benefits must not be delayed pending actual verification/documentation of required items.

Households should be encouraged to provide documentary verification as soon as it becomes available. JOSs/Workers are reminded that for SNAP, identity may be established through the SSN validation process.

#### Welfare Management System (WMS)

The Office of Temporary and Disability Assistance (OTDA) has created three CA case level and three CA line level opening codes which should be used to open the CA cases of evacuees from Hurricanes Harvey, Irma, and Maria:

- Y71 Eligible as a result of Hurricane Harvey
- Y72 Eligible as a result of Hurricane Irma
- Y73 Eligible as a result of Hurricane Maria

Currently, these codes are being tested in POS. In the interim, these cases must be processed in the Paperless Alternate Module (PAM). An update to this procedure will be published when the codes are available in Paperless Office System (POS).
