### REVISIONS TO FORM M-42U AND FORM W-138Q

<p> This procedure can now be accessed on the FIAweb.</p>	<p>The purpose of this policy bulletin is to inform staff at Job Centers and Non-Cash Assistance (NCA) Food Stamp (FS) Centers that the Non-Cash Assistance Food Stamp Centers and Associated Medicaid Offices form (<b>M-42u</b>) and the Food Stamp Income Guidelines form (<b>W-138Q</b>) have been revised.</p> <p>Changes to the <b>M-42u</b>:</p> <ul style="list-style-type: none"><li>• The title of this form has been changed to "Non-Cash Assistance Food Stamp Centers and Associated Medicaid Offices".</li><li>• The text "To file a FS application with the Center nearest you, you may appear in person anytime between the hours of 8:30 AM and 5:00 PM, Monday through Friday" has been added to the statement at the top of the first page.</li><li>• The text "In Extended Hours Centers you may appear in person between the hours of 8:30 AM and 6:00 PM, Monday through Friday (until 7:00 PM on select days) and between 9:00 AM and 5:00 PM on Saturdays" has been added to the statement at the top of the first page. It has also been added as a notation at the bottom of pages 1 and 2.</li><li>• Washington Heights FS Center F13 is now located at 4055 Tenth Avenue, Lower Level, New York, NY 10034.</li><li>• Waverly (F19), Rider (F38) and Fordham (F44) have been added to the FS Center column.</li><li>• Bellevue Hospital has been added to this listing and is the Associated Medicaid Office for F19.</li></ul>

- The Associated Medicaid office for Coney Island (F22) has moved to the "3<sup>rd</sup> Floor" as indicated on the form.
- Lincoln Hospital is the Associated Medicaid Office for F38 and F44.
- Stadium (F31), Far Rockaway (F42), Long Island City (F43), Bergen (F48) and St. George (F51) have been deleted from the FS Center column.
- The Dual Food Stamp/Medicaid Office at Union Square (F11) has been deleted from the form. This Center is scheduled to close in March of 2008.
- F53 (formerly known as "Flushing") is now designated "Queens". The municipality at this location has been corrected to "Long Island City".
- F79 formerly "Far Rockaway" and its Associated Medicaid Office also formerly "Far Rockaway" are each now designated "Rockaway".
- The text "Medical Insurance and Community Services Administration (MICSA) Center" and "F31 does not accept new applicants" (previously located at the bottom of the form on pages 1 and 2) have been removed.
- The address of the Associated Medicaid Office at Bronx Lebanon Hospital has been amended to include the text "First Floor".
- The terms "engageable" and "unengageable" have been removed from the form.

#### Changes to the **W-138Q**:

- The Food Stamp Resource Limits/Exemptions section has been deleted and the form is now one page.
- The sentence "To file a FS application with the Center nearest you, you may appear in person between the hours of 8:30 AM and 5:00 PM, Monday through Friday" has been added to the line immediately following the second set of bullets on the form.
- The sentence "In Extended Hours Centers you may appear in person between the hours of 8:30 AM and 6:00 PM, Monday through Friday (until 7:00 PM on select days) and between 9:00 AM and 5:00 PM on Saturdays" has been added to the line immediately following the second set of bullets on the form.

Since January 1, 2008, categorically eligible households have been exempt from the FS resource limit. See [PB #07-155-ELI](#)

- F11, F31, Colgate (F32), F42, F43 and F51 have been removed from the form.
- F13 is now located at 4055 Tenth Avenue, Lower Level, New York, NY 10034.
- F19 has moved to the "4<sup>th</sup> Floor" as indicated on the form.
- Williamsburg (F21) has moved to the "4<sup>th</sup> Floor" as indicated on the form.
- F22 has moved to the "1<sup>st</sup> Floor" as indicated on the form.
- FS Center F79 is now designated as "Rockaway".
- The text "F31 does not accept new applicants" has been removed.

### Food Stamp Income Guidelines

- Food Stamps provide your family with assistance when buying food. They are used in place of cash to buy food at grocery stores or supermarkets.
- You don't have to be out of work to apply for Food Stamps. You can be employed and still be eligible for Food Stamps.
- You can own your own home and car and still be eligible for Food Stamps.
- If you are eligible, you will receive Food Stamp assistance within 30 days. Certain households with little income or savings, or with high shelter costs, can receive Food Stamp benefits within five days.
