## LETTER FOR CERTAIN SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) CASES BETWEEN 2014 AND 2017

<b>Date:</b> August 10, 2017	Subtopic(s): EBT, CBIC
	The purpose of this policy bulletin is to inform Cash Assistance (CA) and Non-Cash Assistance Supplemental Nutrition Assistance Program (NCA SNAP) staff that a letter was sent to a small number of households that received SNAP benefits from 2014 to 2017 and were identified as having SNAP benefits fraudulently removed from their Electronic Benefit Transfer (EBT) account by a Human Resources Administration (HRA) employee. A sample letter is attached. This policy bulletin is informational for all others.
Individuals who have questions about the letter must call <b>718-722-8001</b> .	Letters were sent to the mailing address on file for current SNAP cases and the last known address for closed SNAP cases. Individuals who have questions are instructed to call 718-722-8001, listed at the bottom of the letter, and will speak with a Bureau of Fraud Investigation (BFI) staff member.
OBA will process all reimbursements.	The Office of Budget Administration (OBA) will mail payments for the amount that is due to each SNAP household. The payments will be mailed to the affected SNAP households within 30 days of the mailing of the letter discussed in this policy bulletin. These payments will not be in the Welfare Management System (WMS).
Job and NCA SNAP Centers <b>must not</b> issue checks to the affected households.	Note: Center staff does not need to take action on the affected SNAP cases and should not issue checks to individuals who present the attached letter at a Center.  Effective Immediately
