What do you do if you think our decision is wrong, or if you do not understand our decision?

Talk to one of our SNAP supervisors right away. You can have a Conference with a supervisor to review a decision you think is wrong or do not understand. If you still disagree or do not understand, you have the right to a Fair Hearing. A Conference could be the fastest way to get help and fix any problems with your SNAP case or benefits. You can ask for one even if you have already asked for a Fair Hearing.

A CONFERENCE IS NOT A FAIR HEARING. If you are told that your case is being closed, or that the SNAP benefits you are getting will stop or decrease, and the problem is not settled with a Conference, you must ask for a Fair Hearing to keep getting benefits.

UNA CONFERENCIA NO ES LO MISMO QUE UNA AUDIENCIA IMPARCIAL. Si le comunican que su caso de SNAP se cerrará, se suspenderá o que se reducirán sus beneficios y el problema no ha sido resuelto mediante una conferencia, usted tiene que solicitar la audiencia impercial para poder seguir recibiendo beneficios.

Kisa pou ou fè si ou panse desizyon nou an pa bon, oswa si ou pa konprann desizyon nou an?

Pale avèk youn nan sipèvizè S NAF yo touswit. Ou ka fe yon konferans ak yon sipevizè pou egzami nen yon desizyon ou panse ki pa bon oswa ou pa konprann. Si cu tou ou dakò oswa ou pa konprann, ou gen dwa pou fè yor. Odyans san Patipri.

Yon Konferans te ka fason ki pi rapid pou jwenn èd ak rezoud nenpôt pwoblè mak dosye oswa avantaj SNAP ou yo. Ou ka mande youn mer ms/ou te deja mande pou yon Odyans san Patipri. YON REYINYON SE PA YON ODYANS SAN PATIPRI. Si nou di ou y at fènien dosye ou, oswa avantaj SNAP wap resevwa pral chanje, epi pwoblèm nan pa rezoud ran yon Konferans ou dwe mande pou fè yon Odyans san Patipri peu w ka kontinye resevwa avantaj yo.

Que faire si vous estimez notre dé cision incorrecte, ou si vous ne comprenez pas not e dé cision ?

Parlez-en in médiatement avec l'un de nos superviseurs du Programme spécial de nutrit on supplémentaire (Supplemental Nutrition Assistance Program, SNAF). Une commission peut être organisée avec un superviseur pour examiner une décision que vous estimez incorrecte ou que vous ne comprenez pas. Si vous contestez toujours la décision ou ne comprenez toujours pas, vous avez le droit de demander une audience équitable.

Une commission peut être le moyen le plus rapide d'obtenir de l'aide et de résoudre tout problème concernant votre dossier ou vos allocations SNAP. Vous pouvez en demander une même si vous avez déjà déposé une demande d'audience équitable. UNE COMMISSION N'EST PAS UNE AUDIENCE ÉQUITABLE. Si vous apprenez que votre dossier est clôturé, ou que les allocations SNAP que vous percevez seront interrompues ou minorées, et que le problème n'est pas réglé malgré la mise en place d'une commission, vous devez demander une audience équitable pour continuer à recevoir vos allocations.

Что делать, если вы считаете вынесенное решение неверным или не понимаете его?

Как можно скорее поговорите со старшим специалистом программы дополнительной продовольственной поддержки (SNAP — Supplemental Nutrition Assistance Program). Вы можете провести собеседование со старшим специалистом и пересмотреть решение, которые вы считаете неправильным или не понимаете. Если после собеседования вы все равно не согласны с решением или не понимаете его, у вас есть право на объективное разбирательство.

Собеседование может быть самым быстрым способом получить помощь и решить все проблемы в связи с вашим делом или пособием по программе SNAP. Вы можете попросить о собеседовании, даже если вы запросили объективное разбирательство. СОБЕСЕДОВАНИЕ НЕ ЯВЛЯЕТСЯ ОБЪЕКТИВНЫМ РАЗБИРАТЕЛЬСТВОМ. Если вам сообщили, что ваше дело закрывают или что вам прекратят предоставлять пособие по программе SNAP либо снизят его, и при этом проблема не урегулирована в ходе собеседования, вы должны подать запрос на объективное разбирательство, чтобы продолжать получать пособия.

Co zrobisz, jeśli uważasz, że nasza decyzja jest błędna lub jeśli nie rozumiesz naszej decyzji?

Porozmawiaj niezwłocznie z jednym z naszych kierowników SNAP. Możesz przeprowadzić spotkanie nieformalne z kierownikiem, aby przejrzeć decyzję, która Twoim zdaniem jest błędna lub niezrozumiała. Jeśli nadal nie zgadzasz się lub nie rozumiesz decyzji, masz prawo wystąpić o bezstronne postępowanie wyjaśniające.

Spotkanie nieformalne jest najszybszym sposobem uzyskania pomocy i rozwiązania wszelkich problemów dotyczących sprawy lub świadczeń SNAP. Można o nie wnioskować nawet w przypadku wcześniejszego złożenia wniosku o bezstronne postępowanie wyjaśniające. SPOTKANIE NIEFORMALNE NIE JEST BEZSTRONNYM POSTĘPOWANIEM WYJAŚNIAJĄCYM. W przypadku uzyskania informacji o zamknięciu sprawy lub wstrzymaniu/zmniejszeniu otrzymywanych świadczeń SNAP i nieuzyskania rozwiązania podczas spotkania nieformalnego należy wnioskować o bezstronne postępowanie wyjaśniające, aby zachować świadczenia.



당 기관의 결정이 잘못되었다고 생각하거나 당 기관의 결정이 이해가 잘 안 되는 경우 어떻게 해야 할까요?

즉시 SNAP 감독자 중 한 명에게 알려주십시오. 감독자에게 컨퍼런스를 요청해 잘못되었다고 생각하거나 잘 이해가 되지 않는

결정에 대해 검토하실 수 있습니다. 그래도 동의하지 못하거나 이해가 되지 않는 경우 공청회를 요청할 권리가 있습니다.

컨퍼런스가 SNAP 케이스 또는 혜택 관련 문제에 대해 도움을 받고 이를 정정할 수 있는 가장 빠른 방법일 수 있습니다. 이미 공청회를 신청하신 경우라도 컨퍼런스를 요청할 수 있습니다. 컨퍼런스와 공청회는 같은 것이 아닙니다. 귀하의 케이스가 종료되거나 귀하가 받고 있는 SNAP 혜택이 중단 또는 축소될 것이라는 통보를 받고, 컨퍼런스를 통해 문제가 해결되지 않을 경우, 계속 혜택을 유지하려면 반드시 공청회를 요청해야 합니다.

如果您认为我们的决定有误或您不理解我们的决定,该怎么做?

请立即与我们的英中一位 SNAP 主管联络。您可以与主管召开协调会,

审查您认为有误或不理解的决定。如果您仍然不同意或者不理解,您有权申请召开公平听证会。

协调会是获得 SNAP 个案式福利相关协助以及解决问题的最快方法。即使您已申请召开

公平听证会,您仍然可以申请召开协调会。协调会并非公平听证会。如果您被告知您的个案已结案,或者您目前领权的 SNAP 福利即将停止或减少,并且协调会并未解决该问题,

则您必须申请召开公平听证会,才能继续领取福利。

假如您認為我們的決定有誤或不理解我們的決定,該怎麼辦?

請立即與我們的 SwAP 主管之一聯繫。您可以與主管召開調解會,

針對您認為有誤或無法理解的決定進行審查。如果您仍然不同意或

不理解,您有權利要求召開公平聽證會。

召開調解會是獲取 SNAP 個案或福利相關協助或修正問題的最快方式。即使您已要求舉行公平聽證會,您仍然可以要求召開調解會。調解會並非公平聽證會。如果您被告知您的個案即將結案,或者您目前領取的 SNAP 福利即將終止或減少,而且問題未能透過調解

會妥善解決,則您必須要求舉行公平聽證會,才能繼續領取福利。

ماذا تفعل إن كنت تعتقد ان فرارنا خاطئ، او إذا كنت لا تفهم قرارنا؟

تحدث إلى أحد مشرفي SNAP التابعين لنا على الفور. يمكن عقد جلسة مراجعة مع أحد المشرفين لمراجعة القرار الذي تعتقد أنه خاطئ أو لا تفهمه. إذا كنت لا توافق أو لا تفهم الأمر، فإنه يحق لك طلب عقد جلسة استماع عادلة.

قد تكون جلسة المراجعة هي الطريق الأسرع للحصول على المساعدة ومعالجة أي مشكلات متعلقة بحالة SNAP الخاصة بك أو مخصصاتك. يمكنك طلب عقد جلسة مراجعة إذا كنت قد طلبت عقد جلسة استماع عادلة. جلسة المراجعة ليست جلسة استماع عادلة. إذا تم إخبارك بأن الحالة الخاصة بك قد تم إغلاقها، أو بأن مخصصات SNAP التي تتلقاها سيتم إيقافها أو تقليلها، ولم يتم حل المشكلة من خلال جلسة المراجعة، يجب عليك أن تطلب عقد جلسة استماع عادلة لمواصلة الحصول على المخصصات.

اگر آپ کے خیال میں ہمارا فیصلہ غلط ہے یا اگر آپ کو ہمارا فیصلہ سمجھ میں نہیں آتا ہے توآپ کیا کریں گے؟

اسی وقت ہمارے ایک SNAP سپروائزر سے بات کریں۔ آپ کے خیال میں جو فیصلہ غلط ہے یا جسے آپ نہیں سمجھتے ہیں اس کا جائزہ لینے کے لیے آپ سپروائزر کے ساتھ کانفرنس کر سکتے ہیں۔ اگر آپ اب بھی اختلاف کرتے ہیں یا آپ کو سمجھ میں نہیں آتا ہے تو آپ کو منصفانہ سماعت کا حق ہے۔

کانفرس مدد حاصل کرنے اور آپ کے SNAP کے کیس یا فوائد میں کسی مسئلے کو ٹھیک کرنے کا تیز ترین طریقہ ہو سکتا ہے۔ اگر آپ نے منصفانہ سماعت کے لیے درخواست کی ہے تو بھی آپ ایک منصفانہ سماعت کی درخواست کر سکتے ہیں۔ کانفرنس منصفانہ سماعت نہیں ہوتی ہے۔ اگر آپ کو بتایا جاتا ہے کہ آپ کا کیس بند کیا جا رہا ہے یا آپ کو SNAP کے جو فوائد مل رہے ہیں وہ بند ہو جائیں گے یا گھٹ جائیں گے اور کانفرنس میں مسئلے کا تصفیہ نہیں ہوتا ہے تو فوائد حاصل کرتے رہنے کیلئے آپ کو منصفانہ سماعت کی گزارش کرنا ضروری ہے۔

যদি আপনাব মনে হয় আমাদেব সিদ্ধান্ত ভুল বা আমাদেব সিদ্ধান্ত বুঝতে না পাবেন তাহলে কি কববেন?

আমাদের SNAP সুপারভাইজারদের সঙ্গে সরাসরি ফোন করুন। যে সিদ্ধান্ত ভুল বা বুঝতে পারছেন না তা পর্যালোচনা করার জন্য সুপারভাইজারের সঙ্গে আপনি কথা বলতে পারেন। যদি আপনি এখনও সন্মত না হন বা বুঝতে না পারেন তাহলে আপনার ন্যায্য শুনানির অধিকার আছে।

সহায়তা পাওয়া বা SNAP কেস বা সুবিধার কোন সমস্যা সমাধানের দ্রুত উপায় হল একটি কনফারেন্স। আপনি ন্যায্য শুনানি চেয়ে থাকলেও আপনি কনফারেন্সের জন্য বলতে পারেন। কনফারেন্স ন্যায্য শুনানি নয়। যদি আপনাকে বলা হয় যে আপনার কেস বন্ধ হবে বা আপনি যে SNAP সুবিধা পান তা বন্ধ হবে বা কমে যাবে এবং কনফারেন্সের মাধ্যমে সমস্যার সমাধান না হলে সুবিধা পাওয়া চালিয়ে যেতে আপনাকে <u>অবশ্যই</u> ন্যায্য শুনান্ধর জন্য বলতে হবে।
