The purpose of this policy bulletin is to inform all staff that the Mandated Job Center Signage (M-98c) and the Mandated Non Cash Assistance Supplemental Nutrition Assistance Program (NCA SNAP) Center Signage (M-98d) lists have been updated. The M-98c and M-98d have been revised as follows: The "And Justice for ALL" (AD-475B) poster date has been updated. The "SNAP Right to File" (LDSS-4995) poster date has been updated. The "Will You Still Receive Supplemental Nutrition Assistance Program (SNAP) After Cash Assistance Ends?" (LDSS-4996) poster (English and Spanish) title and description was changed from FS to SNAP and the poster dates have been updated. The "SNAP Benefits Complaint Procedure" (LDSS-8036) (English and Spanish) poster was changed from FS to SNAP the English poster date has been updated. The "311 Informational Poster" (FIA-72) (English and Spanish) is now obsolete and should be removed. The "Be Careful about who Cares For Your Child" sign (FIA-85) (English and Spanish) is now obsolete and should be removed. The "Workplace Violence Prevention Policy Statement" (POST-95) poster date has been updated. The "NYS Agency Based Voters Registration" (POST-101) poster (English and Spanish) date has been removed.

Job Center and NCA SNAP Center Directors must ensure that all previous versions of the **M-98c** and **M-98d** are removed and recycled and that all mandated signage in their center is updated according to the most recent versions of the **M-98c** and **M-98d**.
