| | <p>The purpose of this policy bulletin is to inform all Job Center and Non Cash Assistance (NCA) Supplemental Nutrition Assistance Program (SNAP) Center staff that six (6) recurring semi-annual schedules have been revised to reflect the dates from July 2022 through December 2022.</p> <p>The semi-annual 2022 schedules are:</p> <ul style="list-style-type: none"> • EBT Pick-up Schedule July - December 2022 (EBT-52). This form informs applicants of the dates when their benefits are first available to them. • Eligibility Resolution Due Dates for Processing Discrepant Information by Lead Type (W-140W). This form advises staff on the various due dates for processing changes reported by households as well as information received from computer matches and other automated lists. • Recurring Roll Deadline Schedule July - December 2022 (W-203). This form advises staff of the recurring case processing schedule and provides staff with the dates by which changes in a case must be submitted. • NCA SNAP Toe Digit Deadline Schedule July - December 2022 (W-203E). This form advises staff of the recurring case processing schedule and provides staff with the date by which changes regarding SNAP cases must be submitted. • Family Assistance and Non Cash Assistance Supplemental Nutrition Assistance Program (NCA SNAP) Application Timeliness Schedule July - December 2022 (W-204T). This form advises staff of the recurring case processing schedule that provides the eligibility decision due dates for Family Assistance (FA) and NCA SNAP applications. |

- Safety Net Assistance Application Timeliness Schedule July - December 2022 (**W-205R**). This form advises staff of the recurring case processing schedule that provides staff with the eligibility decision due dates and benefit availability dates for Safety Net Assistance (SNA) applications.
