POLICY DIRECTIVE #12-02-ELI

(This Policy Directive Obsoletes PD #11-05-ELI)

EARNED INCOME TAX CREDIT (EITC) AND OTHER TAX CREDITS FOR TAX YEAR 2011

Date: February 8, 2012	Subtopic(s): Tax Credits		
AUDIENCE	The instructions in this policy directive are for staff in all Job Centers and Non Cash Assistance Food Stamp (NCA FS) Centers and are informational for all other staff.		
POLICY	The Federal government, New York State (NYS), and New York City (NYC) provide various tax credits that aid families and individuals with low to moderate income by reducing their tax liability. Earned Income Tax Credit (EITC) refunds must be excluded as income and resources for Cash Assistance (CA) and Food Stamp (FS) purposes.		
BACKGROUND	There are several Federal, NYS, and NYC tax credits available to families and individuals with low to moderate income. These tax credits are an important tool in the reduction of poverty and they provide a source of additional income for their recipients. Some of the available tax credits are refundable, in that if the credit exceeds the amount of tax owed, the balance is returned to the taxpayer in the form of a tax credit. The following tax credits are currently available to NYC residents:

Income RequirementsFederal, NYS, and NYC EITCs are refundable tax credits available to
low income wage earners (including the self-employed). In order to
be eligible for an EITC, an individual must have worked full- or part-
time at some point during the previous tax year. Individuals filing for
an EITC must not have investment income totaling more than
\$3,150. Individuals will only receive an EITC refund if the EITC credit
exceeds the amount of taxes owed.The Federal EITC can be claimed by filing IRS Form 1040, Form
1040A, or Form 1040EZ. Full- and part-year residents of NYC who
claim a Federal EITC may also be eligible for NYS and NYC EITCs.

claim a Federal EITC may also be eligible for NYS and NYC EITCs. The NYS Claim for Earned Income Credit (**IT-215**) form must be completed and attached to the NYS income tax return in order to claim the NYS and NYC EITCs. The NYS EITC is equal to 30% of the allowable Federal EITC for tax year 2011. The NYC EITC is equal to 5% of the allowable Federal EITC for tax year 2011. For part-year NYC residents, the amount of EITC is adjusted based on the amount of income received in the NYC residency period.

Increased tax benefits Individuals who file Federal and State tax returns and qualify for EITCs may receive benefits totaling more than \$7,700. For example, a single parent with three or more children in his/her home may be eligible to receive up to \$7,763 in combined City, State, and Federal EITCs (see tables on the next page).

Note: "Qualifying children" for EITCs are children who lived with the individual claiming the credit for at least one-half year and:

- were under the age of 19 at the end of the year for which the credit was claimed; or
- were full-time students and under the age of 24 at the end of the year for which the credit was being claimed; or
- were totally and permanently disabled (regardless of age) at any time during the year for which the credit was claimed.

Increased income limits

The 2011 tax year income limits for EITCs are as follows:

Three or more qualifying children	\$43,998 (single or head of household) \$49,078 (married, filing jointly)
Two qualifying children	\$40,964 (single or head of household) \$46,044 (married, filing jointly)
One qualifying child	\$36,052 (single or head of household) \$41,132 (married, filing jointly)
No children	\$13,660 (single or head of household) \$18,740 (married, filing jointly)

Retroactive EIC Persons who did not claim an EITC during previous tax years may be eligible for retroactive EITC payments. Retroactive Federal, NYS, and NYC EITCs may be claimed for up to three years prior to the current tax year (i.e., tax years 2010, 2009, and 2008).

An income tax return must be filed for each year a retroactive Federal, NYS, or NYC EITC is requested. Those who filed a Federal tax return but did not claim the Federal EITC must file an Amended U.S. Individual Income Tax Return (**Form 1040X**) and attach it to the copy of the tax return from the year for which the credit is being claimed.

In order to claim retroactive NYS and NYC EITCs, individuals must file the Claim for Earned Income Credit (**Form IT-215**) along with a copy of the NYS income tax return from the tax year(s) for which the ETICs are being claimed. To obtain a copy of Form **IT-215** or transcripts of prior NYS tax returns, individuals should call the NYS Department of Taxation and Finance at **(518) 457-5431**. For further information about retroactive eligibility, the individual may call the Internal Revenue Service (IRS) at **(800) 829-1040** (for information about the Federal EITC) and/or the NYS Department of Taxation and Finance at **(518) 457-5431** (for information about the NYS EITC or the NYC EITC).

EIC for CA and/or FS households with "child-only" cases, in which the payee is a grandparent or other relative with earned income, may be EITC eligible. The children in these cases often meet the definition of qualifying children for an EITC, making the payee eligible to receive Federal, NYS, and NYC EITCs.

Noncustodial Parent The NYS Noncustodial Parent EITC addresses the needs of lowincome noncustodial parents by supplementing their earnings and helping qualified taxpayers become more involved in the economic and social well-being of their children. To be qualified, a noncustodial parent must:

- not have claimed NYS EITC;
- be a New York resident taxpayer;
- be 18 years of age but younger than 66;
- be a noncustodial parent and have a child(ren) who does not reside with him/her;
- have paid child support through a NYS Child Support Collection Unit for at least one-half year; and
- have paid 100% of the current amount of child support due for any tax year for which the Noncustodial Parent EITC is claimed.

In order to receive the credit, individuals must attach the Claim for Noncustodial Parent New York State Earned Income Credit Form (IT-209) along with Form IT-215 to their NYS tax returns.

Note: The amount of EITC received by a noncustodial parent has no effect on the amount of EITC a custodial parent receives.

Penalty forAn improper claim resulting from reckless or intentional disregard ofImproper orIRS rules and regulations may lead to a two-year denial of Federal,Fraudulent EITCNYS, and NYC EITCs. Fraudulent EITC claims may lead to a 10-Claimsyear denial of Federal, NYS, and NYC EITCs.

Child Tax Credits (Federal and NYS Empire State) The Federal Child Tax Credit, worth up to \$1,000 for each child under the age of 17, is a non-refundable credit used to reduce the amount of tax owed and may be claimed on the individual's Federal tax return. If the Federal Child Tax Credit exceeds the amount of tax actually owed, the taxpayer may claim the difference in the form of an Additional Child Tax Credit. The Additional Child Tax Credit is a refundable credit which may be claimed by filing the IRS Additional Child Tax Credit Form (**Form 8812**) along with a Federal income tax return. The minimum earned income amount used to calculate the Additional Child Tax Credit is \$3,000 for the 2011 tax year.

The NYS Empire State Child Credit is a refundable tax credit that can be claimed for each child age 4 through 16. Taxpayers who claimed the Federal Child Tax Credit for children age 4 through 16 can claim an Empire State Tax Credit equal to the greater of:

- \$100 times the number of children age 4 through 16 who qualified for the Federal Child Tax Credit; or
- 33% of the taxpayer's Federal Child Tax Credit for children ages 4 through 16.

Eligible taxpayers who did not claim the Federal Child Tax Credit can claim an Empire State Child Tax Credit equal to \$100 times the number of qualifying children. The State Claim for Empire State Child Credit Form (**IT-213**) is used to claim this credit.

Working families can claim the Federal Child Tax Credit and the NYS Empire State Child Credit in addition to the EICs.

Child and Federal, NYS, and NYC Child and Dependent Care credits cover child care and dependent care expenses. These credits are awarded to individuals who pay for the care of a child, spouse, or dependent while they work or seek employment.

The Federal Child and Dependent Care expenses credit is nonrefundable. It can be worth up to \$1,050 for families with one child or dependent in care and up to \$2,100 for families with more than one child or dependent in care. Child care expenses covered under the Federal credit must be for children who were under the age of 13 or disabled during the tax year for which it is being claimed. The Federal credit may be claimed by filing the IRS Child and Dependent Care Expenses (**Form 2441**) and attaching it to IRS Form **1040** or completing IRS **Schedule 2** and attaching it to IRS Form **1040A**.

The NYS Child and Dependent Care Credit is a refundable tax credit worth up to \$1,155 for families with one child or dependent in care and up to \$2,310 for families with more than one child or dependent in care. Expenses covered by this credit must be for children who were under age 13 or for disabled dependants during the tax year for which it is being claimed. The NYC Child and Dependent Care Credit is also a refundable tax credit. This credit covers child care expenses for children who were under the age of four on December 31, 2011. Individuals who do not qualify for the Federal Child and Dependent Care credit are not eligible for NYS or NYC credits. The NYC and NYS credits are to be claimed on the NYS Claim for Child and Dependent Care Credit Form (**IT-216**).

NYS and NYC Household Credits The NYS Household Credit is a non-refundable credit that can only be applied to an individual's NYS personal income tax. The income limits and Household Credit amounts are listed in the table below:

Filing Status	Federal Adjusted Income	Household Credit Amount
 Single Married filing jointly; Qualifying widow(er) with dependent child(ren); or Head of Household 	\$28,000 or less \$32,000 or less	Up to \$75 \$20-\$90, plus an additional \$5 to \$15 per additional exemption claimed on the Federal return
Married filing separately	Follow instructions on the NYS income tax form	

In addition to the NYS Household Credit, NYC residents may be eligible for a NYC Household Credit. These credits may be claimed directly on the NYS tax return.

Education Credits (American Opportunity, Lifetime Learning, and NYS College Tuition Credits) The American Opportunity and Lifetime Learning tax credits are Federal education tax credits that are available to eligible college students. These credits help to offset the cost of higher education by reducing the amount of income tax owed. American Opportunity and Lifetime Learning tax credits may either be claimed by the student or on behalf of the student by the person paying the tuition. To apply for these education tax credits individuals must complete IRS **Form 8863**, Education Credits (American Opportunity, and Lifetime Learning Credits).

	• American Opportunity Credit: This credit applies to the first four taxable years of post-secondary education. A portion of the credit is now refundable for most taxpayers. The maximum amount for the American Opportunity Credit is \$2,500 per student.
	• Lifetime Learning Credit: This non-refundable credit is available for students at any point in their post-secondary education. The Lifetime Learning Credit provides a maximum of \$2,000 per tax return, regardless of the number of eligible students in the family.
NYS College Tuition Credit/Itemized Deduction	In addition, a college tuition credit of up to \$400 is available to eligible full-year residents of NYS if they paid qualified college tuition expenses to an institution of higher education for themselves or on behalf of an eligible student. Alternatively, an itemized deduction may be claimed for NYS college tuition. This NYS College Tuition Credit or itemized deduction may be claimed by filing NYS Form IT-272, Claim for College Tuition Credit or Itemized Deduction.
NYC School Tax Credit	The NYC School Tax Credit is a refundable credit available to individuals residing in NYC with incomes of up to \$250,000. Filing status single, married filing separately, or head of household may receive a credit worth up to \$62.50 if they qualify. Filing status married filing jointly, or qualifying widow(er) with dependent child may receive a credit worth up to \$125 if they qualify. The NYC School Tax Credit can be claimed using the NYS Claim for NYC School Tax Credit (NYC-210) form, or directly on the NYS Resident Income Tax Return (short form) (IT-150), Resident Income Tax Return (long form) (IT-201), or Nonresident and Part-Year Resident Income Tax Return (IT-203).
NYS Tax Rebate Debit Card	On the NYS income tax return, filers may choose to receive refunds via the NYS Tax Rebate Debit Card. This state-administered prepaid card enables filers to avoid check cashing fees and is a useful option for those who do not have bank accounts. There is no charge for in- network ATM cash withdrawals or purchases, or to remove cash from the card in one bank teller transaction. Refunds on direct deposit and paper check are still available.
REQUIRED ACTION	JOS/Workers at Job Centers and NCA FS Centers must inform all applicants/participants about the availability of Federal, NYS, and NYC EITCs. They should also inform applicants/participants about the availability of other tax credits for which they may be qualified.
"Child-only" payee cases	Note: Payees of "Child-only cases" (for example, a grandparent payee that is not receiving cash assistance and has earned income) must also be informed of EITC and tax credit availability.

JOS/Workers must encourage applicants/participants to utilize the VITA centers located throughout the five boroughs of NYC. The Department of Consumer Affairs (DCA)/Office of Financial Empowerment (OFE)'s Volunteer Income Tax Assistance (VITA) and Free Sites for 2012 (**Attachment A**) contains a directory of all VITA sites throughout NYC and it must be distributed during any in-person applicant/participant contact. The DCA/OFE VITA and Free Sites for 2012 directory is also available in Spanish (see **Attachment B**).

JOS/Workers must print copies of **Attachment A** or **B** which is attached to this document until hard copies are delivered to the Centers.

JOS/Workers must direct applicants/participants to contact **311** to obtain a listing of VITA sites in foreign languages other than Spanish.

Note: Additional VITA sites may open after the publication of the directory. JOS/Workers are to advise applicants/participants to contact **311** for the most updated VITA information.

An informational mailing was sent to all active CA households that had earned income in 2011. The mailing consists of an informational letter from the Human Resources Administration (HRA), a multilingual insert, and a copy of the EITC palm card produced by the Department of Consumer Affairs/Office of Financial Empowerment (DCA/OFE).

DCA/OFE's EITC palm card titled "It's Tax Time. Go Get Your Refund" (Attachment C) will also be included in the CA and NCA FS application kits. The palm card provides information on the benefits of EICs and the New York City Child Care Tax Credit. Individuals are directed to call 311 or visit www.nyc.gov/ofe for information on obtaining free or low cost tax preparation assistance. The palm card contains information in both English and Spanish. Job Center Directors and NCA FS Center Directors must ensure that all copies of **Attachments A**, **B**, and **C** are removed from circulation and recycled after April 17, 2012.

Mandated Signage See <u>PB #12-05-ELI</u>. Job Center Directors and NCA FS Center Directors must prominently display the 2012 EIC poster titled "It's Tax Time. Go Get Your Refund!" (**FIA-36**). The 11-by-17 inch poster, which is printed in both English and Spanish, has been distributed to all Job Centers and NCA FS Centers under separate cover. Job Center Directors and NCA FS Center Directors must ensure that outdated versions of **FIA-36** have been removed from circulation and recycled. Additional copies of **FIA-36** can be requested via the Central Intake Workflow System (CIWS) if necessary.

	Tax Credits other than EITCs Tax credits other than EITCs are excluded as income. For those few FS households still subject to a resource test, the amount of the credit or any unspent balance is excluded as a resource for twelve (12) months following the receipt of the credit.

	Income Tax Refunds Income Tax Refunds are excluded as income. For those few FS households still subject to a resource test, the Income Tax Refunds are excluded as a resource for twelve (12) months following the month of receipt. Any remaining, identifiable balance of an Income Tax Refund would be considered to be a resource after twelve months.
Medicaid Implications	EITCs are excluded as income and resources for Medicaid purposes.
