> MODIFICATION AGREEMENT BETWEEN NEW YORK CITY HUMAN RESOURCES ADMINISTRATION/DEPARTMENT OF SOCIAL SERVICES AND THE RICHMOND COUNTY DISTRICT ATTORNEY'S OFFICE

This MODIFICATION AGREEMENT ("Modification Agreement") is dated March 28, 2018, and is between the New York Human Resources Administration/Department of Social Services ("Department" or "HRA"), with offices at 150 Greenwich Street, New York, New York 10007 and the Richmond County District Attorney's Office, ("Richmond County DA" or "DA"), with offices located at 130 Stuyvesant Place, 8th Floor, Staten Island, NY 10301 (hereinafter "the Parties").

WITNESSETH

WHEREAS, the Department, as the local social services district ("District"), is required, pursuant to Section 145 of the Social Services Law of the State of New York, to refer to the district attorney's ("DA's") office all cases where the District has reason to believe that a willful act designed to interfere with the proper administration of public assistance and care has been committed; and

WHEREAS, Section 348.2 of the New York State Code of Rules and Regulations requires that the District enter into agreements with appropriate DA's offices to establish referral procedures for all cases in which reasonable grounds exist to believe that an act of welfare fraud has been committed; and

WHEREAS, the Parties have entered into a Cooperative Agreement (the "Agreement") for the above-referenced services for the period from July 1, 2017 through June 30, 2018 with two (2) one (1) year automatic renewal terms commencing July 1, 2018 and ending June 30; 2020; and

WHEREAS, the Budget for the Agreement in the amount of \$150,000.00 covering the period from July 1, 2017 through June 30, 2020 was allocated among four (4) employees of the DA's Office; a Unit Chief, two (2) Assistant District Attorneys (ADA) and one (1) Paralegal; and

WHEREAS, the Parties wish to modify the Budget for the Agreement by re-allocating the Budget amount of \$150,000 among three (3) employees of the DA's office; a Unit Chief, one (1) ADA and one (1) paralegal; and

NOW, THEREFORE, the Parties hereto agree as follows:

1. Except as modified herein or modified previously, all of the covenants, terms and

conditions of the Agreement shall remain unchanged, and are hereby ratified and confirmed as in full force and effect.

REALLOCATION OF BUDGET

The Agreement is hereby modified by reallocating the budget amount of \$150,000.00
