### Section 2

#### I. Purpose

The purpose of this Informational Letter (INF) is to provide social services districts (SSDs) with a revised listing of district of fiscal responsibility (DFR) contacts for Temporary Assistance (TA), Food Stamps (FS), Drug/Alcohol, Medicaid (MA) and program and payment issues for residential programs for victims of domestic violence.

## **II. Background**

00 INF-19 “District of Fiscal Responsibility Procedures” provided SSDs with updated guidelines for processing temporary assistance applications when a person found in one SSD is assumed to be the financial responsibility of another SSD. One of the guidelines instructs the SSD where the applicant is found to contact a representative of the SSD that is assumed to be financially responsible for the applicant. To assist SSDs in identifying representatives who should be contacted when a DFR issue arises, 01 INF-26 “District of Fiscal Responsibility and Drug/Alcohol Contacts” was released December 2, 2001.

94 ADM-11 “Domestic Violence: Eligibility and Payment for Residential Services for Victims”, required SSDs to designate a contact person to be available during regular business hours to receive notification of admissions to residential programs for victims of domestic violence and to serve as a contact for residential programs on any program, or payment issues relating to admission to the residential program.

## **III. Program Implications**

It is anticipated that having a complete and accurate listing of DFR and domestic violence contacts will facilitate compliance with the guidelines found in 00 INF-19 and 94 ADM-11. Therefore, this INF is intended to update the DFR contacts in 01 INF-26 with necessary revisions and to add domestic violence contacts.
