The purpose of this GIS is to inform local DSS workers that the New York State Office of Temporary and Disability Assistance (OTDA) has begun the printing and mailing of reminder letters to New York State Nutrition Improvement Project (NYSNIP) participants who had food stamp cases opened for them automatically as part of the recently completed phased mass openings. The reminder letters will be sent **only to those participants who, thus far, have failed to use any of the food stamp benefits that have been authorized for them.** The letters remind the NYSNIP participants of the availability of their food stamp benefits and the need to redeem at least some of the benefits soon in order to continue to receive the benefits and not have their NYSNIP food stamp case closed.

Enclosed with the reminder letters are a flyer prepared by the Nutrition Consortium of New York State and a listing of Nutrition Outreach and Education Programs (NOEPs). For your information, we have attached samples of the documents. Please note that there are separate upstate and New York City versions of both the reminder letter and the NOEP listings attached. The letters and the Nutrition Consortium flyer are being printed in both English and Spanish on one sheet of paper. The NOEP listings are printed only in English.

As with the recently completed mass openings of NYSNIP cases, the sending of these reminder letters and the subsequent closing of cases will be phased in over several months. A complete schedule of mailing dates and related case closings will be provided in a subsequent GIS.

**This first batch of reminder letters will be sent only to those non-redeeming NYSNIP participants whose food stamp cases were opened automatically, effective July 1, 2004.** Recipients of these letters who still have not redeemed any benefits by Friday, March 11, 2005, will be subject to having all benefits in their EBT food stamp accounts recovered on or about March 12, 2005, and their food stamp cases will be closed immediately following completion of the benefit recovery process.

**The sending of the reminder letters, recovery of benefits and closing of non-redeeming cases will be done automatically. No local district worker action is required.** Food Stamp Case Level Reason Code 'Y96 – Auto Close NYSNIP Shelter Type 98 Case: Failure to Redeem FS' will be used in auto-closing these cases. Code Y96 does not generate a notice. No closing notices are required and none will be sent.

Reports have been sent to the upstate local districts notifying them of non-redeeming Shelter Type 98 NYSNIP participants to whom the reminder letters have been sent. Upstate districts will have received (and will receive with each subsequent mailing of the reminder letters) report '**NYSNIPNR0000 – NYSNIP Cases after 60 Days of Inactivity.**' The report file is broken out by Office/Unit/Worker and has the Case Number and Case Name of each individual to whom a reminder letter has been sent. As stated above, the local district does not need to take any action on these cases. The reports are informational only, and are being provided, at the request of several local districts, to facilitate outreach and redemption rate tracking efforts.

New York City HRA will receive a similar file, **PRNRNM0704**, listing the Case Numbers and Case Names of New York City non-redeeming NYSNIP participants whose cases opened in July, 2004.

Dear NYSNIP Participant:

A few months ago, you received a notice from the New York State Office of Temporary and Disability Assistance (NYSOTDA) about the New York State Nutrition Improvement Project (NYSNIP). Governor George Pataki sought and received approval from the federal government to provide you with additional resources to purchase food. As a result, a food stamp case has been opened automatically for you because you receive Supplemental Security Income (SSI) benefits and according to the Social Security Administration, you live alone.

Our records show that, as of the date on this letter, you have not used any of the food stamp benefits that have been issued to you. **In order to continue to receive benefits under NYSNIP, you must use at least some of the benefits that have been put into an Electronic Benefits Transfer (EBT) account for you.**

**We are sending this letter to remind you to use some of the benefits soon so that we can keep your food stamp case open and you can continue to get food stamp benefits. The account can be accessed by using your New York State Benefit Card to purchase food.**

You will not receive any additional notification about your case if you do not use any of your benefits within three months of the opening date of your case. However, even if your case is closed, you may apply for food stamps again at any time by contacting the NYC Human Resources Administration Food Stamp Center that serves your neighborhood. To find the Food Stamp Center for your neighborhood call 1-800-342-3009.

**If you have not yet used any of your food stamp benefits because you do not know how, or because you have other questions about NYSNIP, the flyer that is enclosed with this letter may help answer some of your questions.** The flyer was prepared by the Nutrition Consortium of New York State. The Nutrition Consortium is not a government agency. It is an independent organization that believes that NYSNIP is a very important nutrition program. That is why they have prepared the enclosed flyer, and why they are working with us to encourage you to use your NYSNIP food stamp benefits soon.

## **GOOD NEWS FOR SSI RECIPIENTS WHO LIVE ALONE !**

There is a **special new food stamp program project**  
that will help you pay for food!

Because you live by yourself and receive SSI,  
**you are getting benefits each month** from the  
"New York State Nutrition Improvement Project" (or "NYSNIP").

NYSNIP doesn't cost you anything,  
and it will help pay for food at most grocery stores.  
**NYSNIP will not change your monthly SSI benefit check!**

NYSNIP gives food stamp benefits on the same plastic card you use for Medicaid.

You get a PIN number for your NYSNIP account. To buy food with NYSNIP,  
you pass your Medicaid card through the machine at the store checkout counter  
and enter your PIN number.

**NYSNIP will help you buy the good food you need  
to stay healthy!**

You have already received a letter from the New York State  
Office of Temporary and Disability Assistance (OTDA)  
telling you all about NYSNIP. **Be sure to read that letter carefully!**

That letter from OTDA has a lot of important information  
about how NYSNIP works.

Since you are getting NYSNIP for the first time, your food stamp benefits start at  
either \$16 or \$20 every month. **However, you may be able to get much more -  
as much as \$149** every month. Simply fill out the form included with your NYSNIP  
letter from OTDA and send it back to your local department of social services.

**Please go shopping and use your NYSNIP food stamp benefits right away**  
(after you get your new PIN number), so that you can keep getting your NYSNIP  
food stamp benefits each month. You can even get a special benefit card that can be used  
by someone you trust, so this person can shop for you using your NYSNIP benefits.

If you have questions about NYSNIP, or the OTDA letter, call one of the Nutrition  
Outreach & Education Programs (NOEPs) on the enclosed list.  
If your county does not have a NOEP, you can call your local  
department of social services or office for the aging.

## **¡BUENAS NOTICIAS PARA LOS BENEFICIARIOS DE SSI QUE VIVEN SOLOS!**

**¡Existe un nuevo proyecto especial de Cupones para Alimentos que le ayudará a cubrir sus gastos de alimentos!**

Dado que usted vive solo(a) y recibe SSI,  
**se le autoriza recibir beneficios mensuales** provenientes del  
"Proyecto de Mejora Nutricional del Estado de Nueva York (NYSNIP)".

El NYSNIP no le cuesta dinero, y lo puede utilizar en al mayoría de los supermercados para ayudar a cubrir los gastos de alimentos

**¡El NYSNIP no afectará su cheque mensual de SSI!**

El NYSNIP le proporciona cupones para alimentos a través de la misma tarjeta plástica que usted usa para Medicaid. Usted recibirá un número personal de identificación (PIN) para su cuenta de NYSNIP. Para comprar alimentos a través del NYSNIP, usted deslizará su tarjeta de Medicaid por la máquina ubicada en el mostrador de la caja registradora e ingresará su PIN.

**¡El NYSNIP le ayudará a adquirir los alimentos apropiados que usted necesita para gozar de buena salud!**

Usted ya recibió una carta proveniente de la Oficina de Asistencia Temporal y Asistencia para Incapacitados del Estado de Nueva York (OTDA) donde se le informaba acerca del NYSNIP. **¡Asegúrese de leerla cuidadosamente!**

Dicha carta de la OTDA contiene información importante acerca de la manera en que funciona el NYSNIP.

Cuando se recibe por primera vez beneficios del NYSNIP, el monto de cupones para alimentos es de \$16 ó \$20 por mes.

**Sin embargo, es posible que reciba mucho más – hasta \$149 por mes.**

Simplemente, complete el formulario que la OTDA le envía junto con su carta del NYSNIP y envíelo a su departamento local de servicios sociales.

**Vaya de compras y use sus cupones para alimentos del NYSNIP inmediatamente** (una vez que tenga su nuevo PIN), de esta manera seguirá recibiendo

mensualmente los beneficios de cupones para alimentos de NYSNIP.

Incluso puede obtener una tarjeta especial de beneficios para que una persona de su confianza, haga las compras por usted usando sus beneficios NYSNIP.

Si tiene preguntas sobre el NYSNIP o sobre la carta de la OTDA, llame a uno de los Programas de Extensión y Educación Nutricional (NOEP- Nutrition Outreach and Education Program) que aparece en la lista adjunta. Si en su condado no hay un NOEP, puede llamar a su departamento local de servicios sociales u oficina para asuntos de tercera edad.
