# **Chapter 57- Cost of Living Adjustment**

[Senate 6457-C by the Rules Committee]

Part C establishes a cost of living adjustment for designated human services programs.

#### **Statutes involved:**

Social Services Law Section 209, para. (g) of subd. 2, amended Section 131-o, para. (e) of subd. 1, amended

Effective date: April 1, 2006

# <u>Chapter 58 – Enhanced EITC/Administrative Reimbursement/Maximization of</u> Work Rates

[Assembly 9558-B by the Rules Committee]

Part I establishes an enhanced Earned Income Tax Credit for noncustodial parents who are current in their child support payments. Part J provides an enhanced administrative reimbursement to local social services districts that meet federally mandated work requirements; authorizes OTDA to maximize work rates by targeting the population of Safety Net families that are counted as Maintenance of Effort (MOE) spending.

**Effective date:** Part I effective immediately. Part J effective April 1, 2006; provided, however, that provisions pertaining to work participation rate maximization are effective October 1, 2006; and provided further that provisions pertaining to additional reporting requirements are effective May 27, 2006.

# <u>Chapter 61 – Penalties for Noncompliance with Work Requirements</u>

[Assembly 10653 by the Rules Committee]

Part D amends the Social Services Law in relation to penalties imposed for noncompliance with public assistance work requirements to add certain plain language notice requirements.

Social Services Law Section 341, subd. 1, amended

Effective date: June 19, 2006

### **Chapter 96 - Notice of Release of Certain Sex Offenders**

[Senate 7277 by Senator Johnson]

Requires the State Board of Parole to provide notice to the appropriate local social services district upon release, parole or release to post-release supervision of level 2 and 3 sex offenders; eliminates the duty of the Department of Correctional Services to provide such notice.

Executive Law Section 259-c, subd. 16, added

Correction Law Section 72-c, repealed

**Effective date:** Immediately and shall be deemed to have been in full force and effect on and after October 1, 2005.

# <u>Chapter 136 – Extension of Definition of Work Activities</u>

[Senate 7041 by Senator Meier]

Extends to June 30, 2008 the definition of countable work activities to include work-study and internships and the requirement that local social services districts make reasonable efforts to assign work activities that do not conflict with a student's academic schedule.

#### **Statutes involved:**

Chapter 534 of the Laws of 2000, section 5, amended

**Effective date:** July 5, 2006 and shall expire June 30, 2008.

# **Chapter 179- Beginning date of the Vietnam War**

[Assembly 6944 by Assemblyperson Aubertine et al.]

Changes the beginning date of the Vietnam War from December 22, 1961 to February 28, 1961 to coincide with the federal government date.

Effective date: July 26, 2006

# <u>Chapter 515 – Increase in Standard of Need</u>

[Senate 7641-A by Senator Meier]

Increases the standards of monthly need for aged, blind and disabled persons used to determine the mandatory state supplementation of federal supplemental security income.

# <u>Chapter 109 – Parenting pilot programs</u>

[Senate 8471 by the Rules Committee]

Part H permits pilot programs in up to five social services districts to be conducted to provide intensive employment and other supportive services including job readiness and job placement services to certain non-custodial parents.

Social Services Law Section 335-c, added

**Effective date:** June 23, 2006

# <u>Chapter 335 – Penalties for noncompliance with income execution for child support</u>

[Senate 6753-A by Senator Volker]

Provides that the penalties assessed against employers and income payors for the failure to comply with income execution for child support and for discrimination against an employee involved in a child support proceeding shall be paid to the creditor and shall be enforced in the same manner as a civil judgment.

Effective date: October 24, 2006

# **Chapter 481 – Application for a Change of Name**

[Senate 6619-A by Senator Duane et al.]

Requires a petitioner to disclose whether the petitioner is responsible for child support payments and whether the petitioner is responsible for spousal support payments in order to submit an application for a change of name.

**Effective date:** August 16, 2006

#### **Chapter 182 – Electronic Access to Public Records**

[Assembly 7993-B by Assemblyperson Latimer et al.]

Provides for electronic access to public records.

State Technology Law
Section 305, subd. 1, amended

**Effective date:** October 24, 2006

# <u>Chapter 492 – Court Costs for Freedom of Information Litigation</u> [Senate 7011-A by Senator DeFrancisco et al.]

Authorizes the request of the payment of court costs under certain conditions in Freedom of Information litigation.
