I. Purpose

The purpose of this Local Commissioners Memorandum (LCM) is to provide social services districts with amended Foster Care Block Grant allocations for State Fiscal Year (SFY) 2006–07. These allocations provide an additional \$1.0 million in funding related to the cost-of-living adjustment (COLA) authorized by Part C of Chapter 57 of the Laws of 2006.

II. Background

Part C of Chapter 57 of the Laws of 2006 provides a new three-year COLA that is designed to address the additional effects of inflation related to payments for foster and adoptive parents, as well as to voluntary agency programs for which the Office of Children and Family Services (OCFS) establishes the Maximum State Aid Rates (MSARs) and Committee on Special Education (CSE) Maintenance Rates. The COLA is based on the most recent United States Congressional Budget Office estimate of the Consumer Price Index (CPI) for all urban consumers. The initial CPI projection used to determine the Foster Care Block Grant allocations published in 06-OCFS-LCM-

02 necessitated a \$9.0 million increase to the Foster Care Block Grant to support the partial year cost of State reimbursement of the rate increases for the period October 1, 2006, through March 31, 2007. The 2.8 percent CPI projection actually used to implement the COLA effective October 1, 2006, provides for an additional \$1.0 million in the Foster Care Block Grant, which is allocated in this LCM.

III. Program Implications

The implementation of the COLA pursuant to Part C of Chapter 57 of the Laws of 2006 involves three implementation dates. The first COLA is effective October 1, 2006, with subsequent COLAs effective April 1, 2007, and April 1, 2008. This LCM adds \$1.0 million in State funding to the SFY 2006-07 Foster Care Block Grant and amends the allocations to the local social services districts (Attachment A) that were previously published in 06-OCFS-LCM-02.

Program implications outlined in the 06-OCFS-LCM-02 published May 12, 2006, are not changed by the publication of this policy. Administrative Directive 06-OCFS-ADM-09 published on December 27, 2006, provides instructions on how to apply the 2.8 percent COLA.

Allocation Methodology

The methodology used to allocate the additional \$1.0 million in State funding to the local social services districts did not change from the original allocation methodology used to allocate the Block Grant in 06-OCFS-LCM-02. The \$1.0 million was added to the base allocation of \$346.05 million, which increased the base to \$347.05 million. The base was distributed to districts according to their respective shares of historical claims. The amended allocations for each component of the SFY 2006-07 Foster Care Block Grant are provided in Attachment A.

The allocations associated with the \$36.45 million set-aside related to reductions in care days remains unchanged.

IV. Fiscal and Claiming

The Foster Care Block Grant is an annual capped allocation for foster care costs that are ordinarily reimbursed during the SFY. The Foster Care Block Grant payments are generally made on a monthly basis, and there is no State share settlement of the claims filed for State reimbursement. The reimbursement schedule below sets forth the relevant periods for the foster care maintenance, administration and tuition costs covered by this year's allocations.

The scheduled time periods relate to when expenditures are paid. If a social services district exceeds its allocation for a particular SFY, there is no additional funding. Any social services district claims submitted for a particular SFY that do not receive State reimbursement during that SFY may not be claimed against that district's block grant apportionment for the subsequent SFY.

There is no Maintenance of Effort (MOE) requirement associated with the Foster Care Block Grant.

Supplemental claims are paid from the Foster Care Block Grant allocation that covers the period when the expenditures are paid by the district for the services or administrative costs, regardless of when the supplemental claims are submitted.

Federal reimbursement will not be affected by this Block Grant and will be settled in the normal manner subject to the availability of Federal funds. Expenditures for allocations included in this LCM are claimed as follows:

Unclaimed Foster Care Block Grant funds from SFY 2006-07 that an eligible district wishes to use during SFY 2007-08 for eligible preventive, independent living and aftercare services must be reported on the "Reimbursement Claim for Special Projects," (LDSS – 3922), with "Saving FCBG 06-07" indicated in the project name box. Costs should be reported in the non-Administrative column. The reported expenditures are eligible for 100 percent State reimbursement up to the amount of the unclaimed Foster Care Block Grant Funds from SFY 2006-07. Any such claims submitted by a social services district for which there are insufficient unclaimed funds available from the district's SFY 2006-07 Foster Care Block Grant allocation are subject to 65 percent State reimbursement net of any available Federal funds.

The reimbursement schedule for SFY 2006-07 Foster Care Block Grant is as follows:

- Foster Care Maintenance: January 1, 2006, through December 31, 2006
- Foster Care Administration: October 1, 2005, through September 30, 2006
- Foster Care Tuition EAF: October 1, 2005, through September 30, 2006
- Non-EAF Foster Care Tuition: January 1, 2006, through December 31, 2006
- Special Project Claims Form: January 1, 2006, through December 31, 2006

EAF Foster Care Maintenance, Administration and Tuition other than TANF EAF JD/PINS and TANF EAF NYC Tuition costs are only counted toward the Foster Care Block Grant if the costs are not eligible to be swapped for Public Assistance reimbursement.
