## Section 2

#### I. **Purpose**

The purpose of this Informational Letter (INF) is to introduce the revised LDSS-4905: "Domestic Violence Information for All Temporary Assistance Applicants (Rev. 10/07)" and to inform local social services districts that these forms have been translated and are now available in different languages.

#### II. Background

The LDSS-4905: "Domestic Violence Information for All Temporary Assistance Applicants" form was formerly known as the Universal Notification Form/"Hand-Out to All Applicants for Welfare". The title of this form has been changed to "Domestic Violence Information for All Temporary Assistance Applicants" and also assigned form number LDSS-4905. This informational form must be included in the application/recertification packets. This information was previously introduced to districts in 07 INF-09.

#### **III. Program Implications**

- 1. There is a minor language change on the form. There is space on the bottom of the form for local districts to include information on their local domestic violence providers and hotline numbers. The language in the boxed-in area on the bottom of the form has been changed from "LDSS Hotline Number" to "Local Domestic Violence Hotline Number".
- 2. This is a reminder that this notice is required to be included in the application and recertification packets. For recertification purposes, this revised version of the form will be electronically generated with Temporary Assistance (TA) recertification call-in notices through the Client Notice System (CNS). This will affect case types 11, 12, 16 and 17.
- 3. This form has also been translated into Spanish, Arabic, Chinese, Korean and Russian. (See the Attachment to this INF for a sample of the English version.)

## **IV.** Forms Ordering Information

 The revised English version of the LDSS-4905: "Domestic Violence Information For All Temporary Assistance Applicants" and the "other than English" versions
LDSS-4905-AR (Arabic), LDSS-4905-CH (Chinese), LDSS-4905-KO (Korean), LDSS-4905-RU (Russian) and LDSS-4905-SP (Spanish) - are not State-printed but are available to local districts in PDF format or as master camera ready copies. The procedures for ordering PDFs or master camera ready copies are listed below.

- The above-referenced documents have also been posted on the OTDA Intranet website at <a href="http://otda.state.nyenet/ldss\_eforms/default.htm">http://otda.state.nyenet/ldss\_eforms/default.htm</a> and are available for downloading by local districts for reproduction locally.
- Upon the release of this INF, all previous versions of the "Domestic Violence Information For All Temporary Assistance Applicants" **must immediately be destroyed** and replaced with the revised 10/07 versions.

# Domestic Violence Information for all Temporary Assistance Applicants

This information is intended to help you determine if you are a victim of domestic violence and to consider ways to help keep yourself and your family safe and self-supporting.

# Are you in danger of your partner or ex-partner doing any of the following:

- Physically hurting you for example, pushing, grabbing, slapping, hitting, choking, or kicking?
- Forcing you to have sex when you don't want to or to do sexual things you don't want to do?
- Threatening to hurt you, your children or someone close to you?
- Constantly putting you down or telling you that you are worthless?
- Stalking, checking up on you or following you?
- Making you afraid?

# What kinds of help are available?

- **Temporary Assistance:** You must meet certain requirements to be eligible for temporary assistance. If you are a victim of domestic violence and believe meeting those program requirements may put you or your children at risk of harm or make it more difficult to escape the abuse you may request a temporary delay (waiver) of certain requirements. For example: meeting all or some employment, child support enforcement or drug and alcohol assessment and treatment requirements may be temporarily delayed. You may complete the Domestic Violence Screening Form and request to see a Domestic Violence Liaison to determine your eligibility for a temporary waiver.
- **Services:** You can call a 24 hour domestic violence hotline for information about emergency shelter, support groups, counseling and your legal rights.
