### I. Purpose

The purpose of this Administrative Directive (ADM) is to publish Final Chargeback Rates for CY2002 through CY2005, as well as CY2007, for care provided to youth placed in facilities operated by the Office of Children and Family Services (OCFS). Final Chargeback Rates for CY2006 were published in a previous ADM (07-OCFS-ADM-16).

#### A. Final CY2002 to CY2005 Chargeback Rates

Final Rates for CY2002 through CY2005 will be used as the basis for making bill adjustments for youth placed in OCFS-operated facilities during these periods, which were previously billed at CY2001 Interim Rates. The bill adjustments calculated for each of these periods will reconcile the difference between amounts previously billed at CY2001 Interim Rates compared to those billed at the Final Rates for each of the years between CY2002 and CY2005, as specified in this ADM.

#### B. Final CY2007 Chargeback Rates

Final Rates for CY2007 will be used as the basis for making bill adjustments for youth placed in OCFS-operated facilities during CY2007, which were previously billed at CY2007 Interim Rates. The calculated bill adjustments will reconcile the difference between amounts previously billed at CY2007 Interim Rates compared to those billed at the CY2007 Final Rates specified in this ADM.

### II. Background

Chargeback rates for OCFS-operated facilities are used for billing the care provided to youth placed in residential programs directly operated by OCFS. Rates used for such billing purposes are initially calculated and billed as “interim rates” subject to a reconciliation of the actual expenditures for each operating period. Localities are required to make payments based on interim rates that are charged to them on a quarterly basis in the OCFS quarterly cost-of-care bills. When “final rates” are determined for each level of care for a prior period, bills that reconcile the differences between interim and final rates approved for prior periods are issued to localities for care provided to youth during those periods.

### III. Program Implications

Final rates for CY2002 through CY2005, as specified in this ADM, have been approved in accordance with Section 529 of the Executive Law. These rates will be used by OCFS to bill for the differences between interim and final rates for youth placed in applicable

OCFS-operated facilities during the period of January 1, 2002, through December 31, 2005.

Final Rates for CY2007, as specified in this ADM, have been approved in accordance with Section 529 of the Executive Law. These rates will be used by OCFS to bill for the differences between interim and final rates for youth placed in applicable OCFS-operated facilities during the period of January 1, 2007, through December 31, 2007.

#### **IV. Required Action**

##### **A. Final CY2002 through CY2005 Chargeback Rates**

Localities will be billed the retroactive adjustments for CY2002 through CY2005 as part of the 1<sup>st</sup> quarter bill for CY2008 based on final rates specified in this ADM for those periods. These adjustment amounts will be reported separately in the bill from the 1<sup>st</sup> quarter CY2008 amounts.

The following extended payment due schedule is applicable to the retroactive adjustments for CY2002 through CY2005:

Final CY2002 Chargeback Payment Amounts	Due 3/31/09
Final CY2003 Chargeback Payment Amounts	Due 3/31/10
Final CY2004 Chargeback Payment Amounts	Due 3/31/11
Final CY2005 Chargeback Payment Amounts	Due 3/31/12

Prepayment of retroactive rate amounts in advance of the extended payment due dates is available through the Case Management Automation Project (CMAP) system.

##### **B. Final CY2007 Chargeback Rates**

Localities will be billed the retroactive adjustments for CY2007 as part of the 1<sup>st</sup> quarter bill for CY2008 based on Final CY2007 Rates specified in this ADM. The adjustment amount based on Final CY2007 Rates will be reported separately from the 1<sup>st</sup> quarter CY2008 bill amounts.

#### **V. Systems Implications**

The newly developed Case Management Automation Project (CMAP) system tracks youth placed in the care and custody of OCFS, and that includes a fiscal component to support the quarterly billings to localities for youth placed in OCFS-operated facilities and programs. Enhancements have been made in CMAP to allow the electronic
