The purpose of this release is to introduce the 10/91 revision to the "WMS Employment Subsystem Codes" (DSS-3794). The code cards are designed to assist employment workers in locating WMS Employment Subsystem data-entered and systems-generated codes, as well as providing definitions for Edit Error Screen Messages.

The latest update (10/91) to the code cards reflects all additions, deletions and changes in codes which have occurred since the last update (8/90).

Listed below is a detailed summary of the changes which were incorporated into this revision:

 $\underline{\text{Page 2}}$ - Under Employability Codes section: Changed the definition of code 35 from "In School Full-Time Age 16-19" to "In School Full-Time Age 16-18".

Page 4 - Under Employment Activity Codes section:

- o Changed the definition of code 31 from "Post Secondary Training" to "Post Secondary Education".
- o Deleted Code "04 Voluntary Work Experience".

$\underline{\text{Page 6}}$ - Under Sanctioned/Ineligible Reason Codes section, added the following codes:

- o 40 Failed to Participate in Drug/Alcohol Treatment Program (45 days)
- o 41 Failed to Participate in Drug/Alcohol Treatment Program (120 days)
- o 42 Failed to Participate in Drug/Alcohol Treatment Program (180 days)

Page 7 - Under Update Screen Messages (WEMUP 1):

- O Deleted Edit Error No. "124 Status Code must be 02-11, 18, 19, 31-33, 35 or 40 when Activity Code equals 04".
- o Deleted Activity Code 04 from Edit Error No. 128.

Page 8 - Under Update Screen Messages (WEMUP 1):

o Added Activity Code 13 to both Edit Error No. 179 and 181.

Trans. No. 91 INF-63

Under the definition for Edit Error No. 160, Activity Code 04 by changing the definition from "...03-05..." to "...03, 05...".

- Changed the definition of Edit Error No. 162 from "Status Code must be 05..." to "Status Code must not be 05...".
- Under the definition for Edit Error No. 173, deleted Activity Code 04.
- Deleted Edit Error No. "169 Activity Code must be 03-05, 11, or 21 when Status Code equals 16".
