The purpose of this INF is to provide social services districts with a chart which summarizes the major components of the various funding sources available for the provision of child care services. A list of relevant Department releases is also provided.

Currently, several funding sources are available for the provision of child care services to low income families in New York State. Some of these programs are entitlements, while others are optional programs in which social services districts may elect to participate. Programs vary in the purposes for which child care is provided, ages of children who may be served, providers eligible for reimbursement, and the source and the levels of reimbursement available to social services districts.

In response to requests for assistance in differentiating between the various funding sources, the Attachment A entitled "Child Care Programs" has been developed. This chart provides regulatory citations and summarizes key factors of financial and programmatic eligibility, eligible child, providers, rates, funding reimbursement and fees for each of the child care programs available in New York State. Attachment B, "Child Care Funding: Relevant Releases" is a program-specific list of Department releases which detail programmatic and claiming information.
