The purpose of this memorandum is to inform local districts that Title IV-E Independent Living allocations for the period 10/01/91 through 09/30/92 have been revised to reflect reconciliation of final district claims for the period of 10/01/90 through 09/30/91.

92-LCM-2 conveyed preliminary allocations to districts prior to the final reconciliation of previous year claims. The release of preliminary funding levels was done to respond to local district requests for information to assist in local planning. However, with the finalization of all claims for district expenditures for the previous year, it is necessary to reduce the amount of federal IV-E Independent Living funds available to local districts for the period of 10/01/91 through 9/30/92.

As opposed to the estimated \$7.8 million in 100% federal funds referenced in the earlier LCM, district allocations have been recalculated based on the availability of approximately \$7.5 million. Similarly, the level of federal Independent Living funds requiring a 50% non-federal match has been reduced from approximately \$5.3 million to \$2 million. The reduction of available funds was necessitated solely by county expenditures, which exceeded state projections. This left less funds than anticipated to be rolled into the current year's allocation. Date February 26, 1992

In calculating the new allocation levels for districts, district expenditure patterns were reviewed. In some instances, patterns of significant underexpenditure of funds resulted in adjustments to the basic allocation formula, which was driven exclusively by districts' shares of the State's eligible population. District allocations are listed on the attachment to this memo.

All other information in the previous LCM continues to be accurate. Any questions concerning your allocation or other aspects of the Independent Living Program should be directed to the appropriate Regional Office of the Division of Family and Children Services.
