SUBJECT: Department Mailing of Notice to Disabled Adult Children (DAC)

This letter is to alert you to a notice that will be sent to all individuals identified by the Social Security Administration as potentially eligible for Medical Assistance (MA) under the Disabled Adult Child (DAC) provision of Section 1634(c) of the Social Security Act (the Act) for the period July 1987 through December 1992. Please see the enclosed listing for the number of DAC cases for your district.

Briefly, Section 1634(c) of the Act extends MA eligibility to certain disabled individuals who lose Supplemental Security Income (SSI) eligibility solely due to the entitlement to or increase in Social Security child's insurance benefits, more commonly referred to as DAC benefits. SSI recipients whose DAC benefits are too high to allow receipt of SSI benefits are allowed to retain their MA eligibility status, if they would be eligible for SSI benefits except for the increase in or entitlement to the DAC benefits.

Individuals eligible under this provision are identified to districts by an SSI Indicator Code of "D" on the SDX. Due to identification problems in the system, a number of individuals were not properly identified as a DAC. The Department currently intends to send a notice to all individuals who may not have been identified as a DAC advising them of their potential eligibility for MA benefits, including possible reimbursement. The notice will

instruct individuals to complete and return a DAC request form if they would like a determination made for payment or reimbursement of past medical bills, reimbursement of Medicare Part B premiums, and/or a redetermination of MA eligibility.

We will be providing stamped return envelopes with the mailing. Would you please advise us of the address/contact person for your district by July 21, 1993. If we do not hear from you, we will use the Medicaid Director as the contact person for the mailing.

Detailed instructions concerning reimbursement for individuals who meet the DAC criteria will be issued when the DAC notices are mailed.
