The purpose of this release is to introduce the new DSS-4279 which combines the material previously contained in the following two forms:

DSS-4279: "The Requirements To Assign Support And Cooperate And Right To Claim Good Cause For Refusal To Cooperate"

DSS-4280: "Right To Claim Good Cause For Refusal To Cooperate With Child Support Enforcement (Second Notice)"

into a single form:

DSS-4279: "Notice Of Responsibilities and Rights for Support" (Rev. 9/93) (copy attached).

Acting on a suggestion from Monroe County to simplify the forms used in the good cause process, the DSS-4279 and DSS 4280 were reviewed, rewritten and reduced into a single 8 1/2" x 11" two-ply carbonized form. A State Plan Amendment was requested from and approved by the Federal government in order to go from the first and second notice format to a single notice.

Districts must continue to give and explain the DSS-4279 (Rev. 9/93) to each Public Assistance (PA) and Medical Assistance (MA) applicant and recipient when a referral is required to be made to the Child Support Enforcement Unit (CSEU) for paternity establishment and/or child support enforcement. If an applicant/recipient indicates on the DSS-4279 (Rev. 9/93) that good cause for refusing to cooperate is claimed, district staff must determine whether good cause exists using the procedures described in PASB VIII-T-1.13-1.18.

The following is an explanation of the delivery schedule for the new English and Spanish forms and what forms are made obsolete by the new forms:

I. Upstate Districts

- A. Delivery of 9/93 English Version of DSS-4279 - Delivery of the 9/93 English version of the DSS-4279 to the Albany Warehouse should be in February 1994. Your district will automatically receive supplies of this form based on previous ordering practices.
- B. Ordering Master of Spanish Version of DSS-4279 (DSS-4279-S) - A clear photocopied master of the revised 9/93 Spanish version (DSS-4279-S) is available and can be ordered by any district which requires Spanish forms. The district must then reproduce the form locally.
- C. Disposition of Existing Forms
 - o DSS-4279 (Rev. 7/92) - All existing copies of this version should be destroyed upon receipt of the 9/93 version of the DSS-4279.

- o DSS-4279-S (Rev. 7/92) - All existing copies of this master should be destroyed after ordering and receiving the 9/93 master of the DSS-4279-S.
- o DSS-4280 (Rev. 7/92) - All existing copies of this version should be destroyed upon receipt of the 9/93 version of the DSS-4279.
- o DSS-4280-S (Rev. 7/92) - All existing copies of this master should be destroyed after ordering and receiving the 9/93 master of the DSS-4279-S.

II. New York City

- A. Delivery of 9/93 English Version of DSS-4279 - Delivery of the 9/93 English version of the DSS-4279 to the NYC/HRA Warehouse should be in February 1994.
- B. Delivery of 9/93 Spanish Version of DSS-4279 (DSS-4279-S) - Delivery of the 9/93 Spanish version of the DSS-4279 (DSS-4279-S) to the NYC/HRA Warehouse should also be in February 1994.
- C. Disposition of Existing Forms
 - o DSS-4279 (Rev. 7/92) - All existing copies of this version should be destroyed upon receipt of the 9/93 version of the DSS-4279.
 - o DSS-4279-S (Rev. 7/92) - All existing copies of this version should be destroyed upon receipt of the 9/93 version of the DSS-4279-S.
 - o DSS-4280 (Rev. 7/92) - All existing copies of this version should be destroyed upon receipt of the 9/93 version of the DSS-4279.
