The new DSS-3035A was designed to provide to SSI recipients and Group Living residents all necessary general and legal information for the Food Stamp Program. The DSS-3035A must be sent/given out with the DSS-3035/DSS-3035 NYC at all times.

Because the DSS-3035A meets the Food Stamp Program's legal requirements and must accompany every DSS-3035/DSS-3035 NYC, the following Client Information Books 1, 2 and 3 no longer need to be sent/given out with the DSS-3035/DSS-3035 NYC:

- DSS-4148A: "What You Should Know About Your Rights And Responsibilities (When Applying For Or Receiving Social Services)"
- DSS-4148B: "What You Should Know About Social Services Programs"
- DSS-4148C: "What You Should Know If You Have An Emergency"

These Client Information Books must continue to be given out at all other times, however, as stated in 93 INF-26.

Although there are Upstate and New York City versions of the DSS-3035, there are not separate Upstate and New York City versions of the DSS-3035A.

Delivery of the DSS-3035A to the Albany and NYC HRA Warehouses should be in July 1994. Your district will automatically receive copies.
