The purpose of this informational letter (INF) is to provide social services districts with a child care regulations guide. This guide will assist social services districts in fulfilling their responsibility to notify applicants for, and recipients of, child care services of the legal authority which supports a case action.

Part 358 of the Department's regulations requires that the regulatory citation(s) supporting any action taken by a social services district on a client's case be included in the notice sent to the client. On January 21, 1993, the Department released 93 INF-5 entitled "Child Care: Revised Client Notification Forms" which introduced model notices which may be used by social services districts to provide notification to clients in accordance with Section 358 of the Department's regulations. Each of the model child care notices includes a section, "The Law(s) and/or Regulation(s) which allows us to do this is: ______," which workers are to complete by inserting the appropriate regulation number(s).

Several social services districts have contacted the Department to request assistance in identifying applicable regulatory citations associated with the common reasons for the denial of a request for services or the discontinuance or change of a client's child care benefits. The Department has developed the "Child Care Regulations Guide" (attached) in response to these requests.

The "Child Care Regulations Guide" identifies regulatory citations for the most common reasons for taking an action. The "reasons" listed are only clues to the proper regulatory citation(s). Alone they may not provide sufficient explanation of the action(s) taken by the social services district. Social services districts retain the ultimate responsibility for ensuring that the reason(s) and regulation(s) cited is/are accurate in the particular case action.
