The Department has selected a contractor for the new Automated Finger Imaging System (AFIS) and has prepared a Memorandum of Understanding (MOU) to allow local districts to participate in the new system. In order to begin implementing early in 1995, local districts will have to choose before December 23, 1994 whether they wish to participate in the AFIS contract.

The Department has arranged a series of informational sessions at various locations throughout the State in order to provide information about the contract and its implications for local districts. These informational Sessions will include representatives from North American Morpho Systems, Inc., the contractor, as well as the Office of Quality Assurance and Audit, Office of Contract Management, Office of Financial Management, Division of Economic Security, Division of Legal Affairs and Office of Field Operations. These informational sessions will last approximately three hours each and include information about both the fiscal and operating aspects of AFIS. They will conclude with a question and answer session. Local officials including local legislators who have responsibility for evaluating county participation in AFIS should consider attending one of these sessions. Because space is limited, we request that you call the contact person for the session you wish to attend by 12:00 noon, Friday, December 9, 1994.
