The New York State Department of Social Services conducted a survey in 1994 on the status of school based preventive services programs in each local social services district. The findings show that these collaborative programs between local social services districts and school districts are developing and expanding throughout the State.

Almost three-quarters of the local social services districts are currently operating a preventive services program that outstations caseworkers in the schools in at least one school district and almost all of the rest are considering or planning to develop a program.

These findings appear to reflect the growing recognition that responding to the needs of children and families requires a holistic, cross-systems approach. Coping with family stresses can affect a child's academic performance, school attendance, and behavior at school. A study of statewide random samples of children entering foster care and families entering the preventive services program presented in the Department's report, Families in the Child Welfare System: Foster Care and Preventive Services in the Nineties, supports this. School-related problems were the most prevalent child problem for both samples - 45% for all preventive services cases and 50% for children in foster care of school age. Of the preventive services cases having a school-related child problem, 38% had parental substance abuse (drug and/or alcohol), 27% had parental mental illness, and 28% had domestic violence, while only 8% of these cases had no family problem identified.

FINDINGS

Survey findings are presented for each local social services district by Regional Office on the attached charts covering the following areas:

- Program Status

This identifies whether the local social services district is one of the forty-two districts currently operating a preventive services program that outstations caseworkers in the schools or whether it is one of those considering or planning to develop such a program. It also identifies the number and in some cases the names of the schools or school districts participating.

- Local Consortium

This identifies whether there is a county/local consortium (ala the Herkimer model) comprised of local policy and decision makers from the local social services districts, school districts, and any other relevant systems that have responsibility for planning and coordinating the program.

- Almost one-half (26) local social services districts reported participating on a local consortium.

◦ Caseworker Employer

This reports on whether the caseworkers outstationed in the schools are or will be direct employees of the local social services district or whether the local social services district contracts with another agency or a school district or BOCES for the caseworkers. Information is presented for local social service districts currently operating programs along with some who are in the planning stage.

- In over one-half (35) of the local social services districts, caseworkers are or will be direct employees of the local social services district. One local social services district utilizes caseworkers employed by another local social services district in a school district that encompasses portions of both local social services districts.
- In 9 of the local social services districts, caseworkers are or will be employed by a private or preventive services agency.
- One local social services district is planning to use BOCES as the caseworker employer.

◦ Funding Source

This reports on the funding source local social services districts are using or planning to use. The use of in-kind/donated funds is included.

- Mandated preventive services is the most frequently used funding source - approximately two-thirds (38) of the local social services districts.
- Non-mandated preventive services - 5 local social services districts.
- Foster care or JD/PINS CAP savings - 4 local social services districts.
- Community Optional Preventive Services demonstration funds - 2 local social services districts.
- Four local social services districts included in the above funding sources are using or planning to use more than one source.
- Almost one-half (27) local social services districts are receiving some in-kind/donated funds as contribution toward the local match. Local school districts are the source for 25 of the local social services districts. (NOTE: The survey may not have captured this information for all local social services districts).
