The Department of Health and Human Services has informed the Department that federal funds will be extended for both the At Risk Low Income Child Care (ARLICC) and Transitional Child Care programs for a three month period. The extension will cover child care subsidies for the period that begins April 1, 1996 and ends June 30, 1996.

Attachment A lists each district's federal allocation for ARLICC for the period April 1, 1996 through June 30, 1996. District allocations for the extension period reflect a slight increase over the previous quarter's allocation. For details on the At Risk program, refer to 95 LCM-93 dated August 15, 1995.

Authority for the Transitional Child Care program also has been extended for the same time period. Funds are available that should allow social services districts to maintain this program at its previous level for the period of the extension. There is no specific district allocation for this program.

You will receive an update on the status of these and other federal child care programs as soon information becomes available.
