This memorandum advises you of the maximum state aid rates (MSARs) and SILP rates for foster care programs, and the CSE maintenance rates for approved residential schools for the period September 1, 1996 through June 30, 1997. The rates that are promulgated in this LCM are calculated using the approved reimbursement methodology for the period September 1, 1996 through June 30, 1997.

NOTE: In 96 LCM-107, you were notified of the MSARs, SILP rates and in-state CSE maintenance rates that are effective for the period July 1, 1996 through August 31, 1996. In 96 LCM-105, you were notified of the out-of-state CSE maintenance rates that are effective for the period July 1, 1996 through June 30, 1997.

A. All MSARs and In-State CSE Maintenance Rates: The following policies are applicable to all MSARs and in-state CSE maintenance rates that are calculated for the effective period September 1, 1996 through June 30, 1997:

1. No COLAs are applied to the historical cost base: In accordance with the existing Model Budget Methodology, the promulgated rates are calculated using the two-year old historical costs and care days with no COLAs applied to either personal services or other-than-personal services costs.

2. COLAs are applied to the Model Budget parameters for other-than-personal services (OTPS) components only: COLAs are applied to the OTPS components based on CPI indices for specific categories (see Attachment E). The CPI indices reflect cost-of-living increases for the period March 31, 1995 through March 31, 1996.

3. 1996/97 rate ranges are established for applying adjustment factors of 4%, 2%, or 0%: With an emphasis on containing costs, but protecting lower-end rates from further reductions, a set of rate ranges or "break points" are established for 1996/97 for purposes of applying an adjustment factor of 4%, 2% or 0% to each calculated program rate. The following methodology was used for establishing the "break points" for this purpose:

a. 1996/97 calculated rates were ranked from highest to lowest within the following groups: All program rates were divided into upstate and downstate groups; group care rates were further divided into group emergency programs, hard-to-place programs, class 1 programs, class 2-5 programs, class 6 programs, and class 7-12 programs; foster boarding home rates were further divided into regular programs (including emergency FBH programs), Therapeutic Foster Boarding Home (TFBH) programs, and special needs programs.

b. 1996/97 ranked rates for each group were divided into thirds: For the purpose of applying the adjustment factors of 4%, 2%, or 0%, "break points" were established for the purpose of ordering the top, middle, and bottom third rate ranges for each classification grouping.

4. Rate adjustments of 4%, 2%, or 0% are applied as follows: The lower of either a 4% reduction, or a reduction to the highest rate in the middle range, is applied to program rates that fall in the upper range of each group. The lower of either a 2% reduction, or a reduction to the highest rate in the lower range, is applied to program rates that fall in the middle range of each group. Program rates that fall in the lower range of each group receive no rate reduction.

5. Applying rate adjustments of 4%, 2%, or 0% to new or revised rates: The "break points" established for each grouping will remain the same for the effective period September 1, 1996 through June 30, 1997. As new rates are established, or rate changes occur during this effective period, the same break points established for each of the three rate ranges will be the basis for determining subsequent rate adjustments of 4%, 2%, or 0%.

6. Rate Stabilization for New Programs: The Department is continuing the rate stabilization policy for all new programs for which we are first using historical program expenses. There is a 10% margin of rate variance. No new program rate will be allowed to go up or down by more than 10% of its prior year's rate. The rate adjustment factor of 4%, 2%, or 0% is applied to the stabilization rate.

B. Group Care Rates: The following policies are specifically applicable to the MSARs and In-State CSE maintenance rates that were calculated for group care programs for the effective period September 1, 1996 through June 30, 1997:

1. Aggregate Cost-of-Living Adjustments (COLAs) applied to Model Budget Parameters:

a. Personnel Services: The two-year aggregate COLA that is used for trending the personnel services parameters is 0.0%.

b. Other Than Personnel Services (OTPS): The two-year aggregate COLA that is used for trending the OTPS parameters is 4.8%.

2. In-State CSE (Committee on Special Education) Maintenance Rates: The in-state CSE maintenance rates promulgated in this LCM for the period September 1, 1996 through June 30, 1997 supersede the interim in-state CSE maintenance rates that were previously sent to approved residential schools for the same period.

The in-state CSE maintenance rate for Special Act School Districts and on-campus schools affiliated with Article 81 institutions is composed of the 1996/97 MSAR for the institution program plus the 1995/96 medical per diem. When the medical per diems for the 1996/97 rate year are approved, the in-state CSE maintenance rates for these programs will be revised to reflect those changes.

The social services district where the child is a legal resident is responsible for the 10-month CSE maintenance payment, and the placing local school district is responsible for the 10-month CSE tuition payment. For CSE summer school placements, the placing school district is responsible for both maintenance and tuition payments.

CSE maintenance rates for children placed by local school districts are not negotiable and must be paid as published.

3. Program Classification Reviews: The Department is continuing its policy of conducting program classification reviews in response to requests from agencies that believe their populations have changed. In addition, the Department will continue its review of new programs that have interim program classifications.

C. CSE Maintenance Rates for Out-of-State Schools: As previously notified in 96 LCM-105, all rates promulgated by other states for SED approved residential schools are accepted by the Department for purposes of reimbursement. Out-of-state rates for CSE placements are not negotiable and must be paid as published.

D. Foster Boarding Home (FBH) Rates: The following policies are specifically applicable to the FBH rates that were calculated for the effective period September 1, 1996 through June 30, 1997:

1. Aggregate Cost-of-Living Adjustments (COLAs) applied to Model Budget Parameters:

- a. Personnel Services: The two-year aggregate COLA that is used for trending the personnel services parameters is 0.0%.
- b. Other Than Personnel Services (OTPS): The two-year aggregate COLA that is used for trending the OTPS parameters is 5.1%.

2. AIDS Per Diem: The \$15 AIDS per diem add-on remains in effect. The treatment of the \$15 per diem revenue for rate setting purposes is as follows: Revenue from the \$15.00 AIDS per diem is subtracted from the trended direct care costs for each FBH program, and the adjusted expenditures are compared with the direct care parameter to determine the rate base.

3. Pass-through to Foster Parents: The maximum state aid rates for foster parents are not increased in FY 1996/97.

4. Clothing Allowance: The maximum clothing allowances are not increased in FY 1996/97.

5. Diaper Allowance: The maximum diaper allowance for infants from birth through three years is not increased in FY 1996/97.

6. Finder's Fee for New Foster Homes: The Department is continuing the policy of allowing local social services districts to pay a voluntary finder's fee of up to \$200 to foster parents who recruit new foster parents. The policy will continue in effect through June 30, 1997. For detailed information on how to apply this policy please refer to 88 ADM-54 dated December 23, 1988.

E. Supervised Independent Living Programs (SILPs): The 1996/97 annual fees for double and triple occupancy and four-bed mother/child SILPS are not increased.
