SUBJECT: FISCAL: Allocation of \$100,000,000 TANF Set-Aside

for Family and Childrens Services (EAF Allocation)

The purpose of this memorandum is to provide social services districts with funds allocations from the State Fiscal Year (SFY) 1997-98 budget of the \$100,000,000 in TANF funds set aside for foster care and other child welfare services provided under the State's Emergency Assistance to Needy Families (EAF) program.

These TANF Set-Aside funds have been allocated on a percentage basis based on each district's claiming history for foster care and other child welfare services under Emergency Assistance for Families (EAF) in FFY 1995/96, net of any retroactive payments and as adjusted by the Statewide Random Moment Study (SRMS) cost allocation plan. The allocation schedule is included with this memorandum as an on-line attachment.

These funds are available to provide foster care and child welfare services under the State's EAF program. The services provided with these funds are subject to the EAF eligibility and need requirements. The funds

are not available for JD/PINS expenditures. Districts are also reminded that, under the federal requirements, using these TANF funds for on-going cash assistance such as Preventive Housing Services rent subsidies to families with an adult or minor-head of household, although provided under Preventive Services eligibility standards, would result in the family being considered to be receiving TANF assistance. Consequently, each month during which such a family receives on-going cash assistance from these funds would count towards the family's 60-month lifetime limit for TANF assistance. It would also result in the family having to be included in the district's work participation rate calculations. It is therefore recommended that districts, whenever possible, use these funds for on-going cash assistance such as Preventive Housing Services rent subsidies only for families with an adult or minor-head of household that are already receiving TANF benefits.

In order to continue the flow of State and federal funds to social services districts while the allocation formula was finalized, the State has been reimbursing social services districts for EAF foster care and child welfare services from these federal funds throughout the year. As a result, the publication of these allocations may result in some social services districts receiving adjustments in the amounts of these funds they already received.
