The purpose of this General Information System (GIS) message is to advise Local Departments of Social Services (LDSS) of a change in the initial Medicaid eligibility period for the Afghan Special Immigrant Visa (SIV) holder. During their initial eligibility period, these Special immigrants are treated as refugees for the purpose of eligibility for federal means tested public benefits, including Medicaid.

GIS 08 MA/012 informed districts that the initial eligibility period for the SIV holder was six months. The 2009 Federal Appropriations Act, enacted on 03/11/09, lengthened the initial Medicaid eligibility period for the Afghan refugee from six months to eight months.

Therefore, effective 03/11/09, the initial period of eligibility has been lengthened from six months to eight months for Afghan Special Immigrants. Districts must extend coverage, as appropriate, for any Afghan Special Immigrant currently in their initial six month eligibility period. To determine the new eligibility period of an Afghan SIV holder, the eligibility worker must identify the date of entry or the date of adjustment of status for the SIV holder and count forward eight months to find the new date on which eligibility expires.

NOTE: The chart below describes the visa category/code that will be stamped in the Afghan passport or appear on the DHS I-551-Lawful Permanent Resident Card (i.e., "green card").
